Pursuant to RAP 10.8, petitioner John Mayfield cites the following additional authorities, with regard to Issue 1 in the Petition for Review, whether a Gunwall analysis is still necessary under article I, section 7:

State v. Witkowski, \_\_Wn. App. 2d\_\_, \_\_P.3d\_\_, No. 49490-6-II, 2018 WL 1918235, at \*8 (Apr. 24, 2018) (majority opinion) (“[W]e conclude that a Gunwall analysis is unnecessary before we undertake an individual state constitutional analysis under article I, section 7.”).

State v. Witkowski, \_\_Wn. App. 2d\_\_, \_\_P.3d\_\_, No. 49490-6-II, 2018 WL 1918235, at \*11 (Apr. 24, 2018) (Sutton, J., concurring) (“Because the parties have failed to provide a Gunwall analysis demonstrating that this court should analyze article I, section 7 independently from the Fourth Amendment in this case, I would decline to consider their article I, section 7 argument.”).
