
Dear Mr. Johnson:

I write to inform the Court of a factual misstatement in the briefs.

The briefs state that Mr. Bagnell told a nurse he had been strangled, citing 8RP 1110 (Opening Brief at 18; Response Brief at 5). The briefs do not state that this witness clarified that Mr. Bagnell had not “used the word strangled.” 8RP 1116. He described an injury on the back of his neck from a sweatshirt pulled tight. *Id.* He did not have trouble breathing, lose consciousness, or have internal throat swelling. 7RP 828, 928; 8RP 1118-19; 11RP 1411.

I apologize for any inconvenience caused by the factual misstatement.
