As a former Federal Employee, DBP, Inc., was founded to help assist Native-American Tribes with Economic Development here in the Pacific Northwest and abroad.

As a Member of the (NSA) National Sheriff Association, and a (23yr) Naval-Military Veteran who served as Direct Administrator/Yeoman to the Commanding Officer Of The USS Carl Vinson (CVN-70), and Intelligence, as an "Oath-Taker" of this Great Nation I find that Justice is warranted in this case.
