RESPONSE OF THE

CORRECTIONS

Respondent, Department of Corrections (Department), submits this response to Mr. Brown's personal restraint petition.

I. BASIS OF CUSTODY

Mr. Brown was released from the Department's confinement, moved to South Dakota, and is currently on community custody there supervised pursuant to the Washington Interstate Compact, RCW 9.94A.745. Exhibit 1, Declaration of Janine Latone, Attachment A, Offender Management Network Information OMNI: Legal Face Sheet.

In 1996, Mr. Brown pled guilty to second-degree child rape and second-degree child molestation. Exhibit 2, Declaration of Christopher Cruzan, Attachment A, Judgment and Sentence, *State v. Brown*, King County Superior Court Cause No. 95-1-07066-0. In 1997, the jury found Brown guilty of three counts of second-degree child rape. Exhibit 2, Attachment B, Judgment and Sentence, *State v. Brown*, Snohomish County Superior Court Cause No. 96-1-00558-9.

In 1997, the Snohomish County superior court ordered to have its judgment and sentence amended to reflect that it was to run consecutively to the King County cause. Exhibit 2, Attachment C, Order Amending Judgment and Sentence Nunc Pro Tunc, *State v. Brown*, Snohomish County Superior Court Cause No. 96-1-00558-9.

II. STATEMENT OF THE CASE

In 1997, the superior court amended Brown's Snohomish County cause by ordering it to run consecutively to the King County cause. In January of 2016, Mr. Brown was released from confinement. Exhibit 1, Attachment A, at 8. He requested and was approved transfer to South Dakota. He is on community custody there until 2020, supervised by the South Dakota Department of Corrections for the two consecutive causes, *above*, pursuant to the Interstate Compact. Since the two causes are running consecutively, the Department is running Brown's community custody supervision on them consecutively as well. Exhibit 1, Attachment B, OMNI: View J & S – Field Screen Printout, Supervision Length, Time Start and Scheduled End Date columns (showing that community custody on the King County cause is running until 1/20/2018, and the community custody on the Snohomish County cause begins on that date and runs until 1/20/2020).

III. STANDARD OF REVIEW

To obtain state judicial review of a decision through a personal restraint proceeding, an inmate is required to demonstrate he or she is being restrained and that the restraint is unlawful. RAP 16.4(a); *In re Dutcher*, 114 Wn. App. 755, 758, 60 P.3d 635 (2002) (citing *In re Cashaw*, 123 Wn.2d 138, 144, 866 P.2d 8 (1994)), *abrogated on other grounds by, In re Mattson*, 166 Wn.2d 730, 214 P.3d 141 (2009). The petitioner may obtain relief by demonstrating either a constitutional violation or a violation of state law. RAP 16.4(c)(2), (6); *Cashaw*, 123 Wn.2d at 148.

If the inmate has had a previous or alternative avenue for obtaining state judicial review of the challenged decision, he or she has a “threshold” burden of establishing the appropriateness of collateral review. *Cashaw*, 123 Wn.2d at 148-49. Upon meeting this threshold, the petitioner has a burden of proving by a preponderance of the evidence that an alleged error caused him or her actual and substantial prejudice. *In re Cook*, 114 Wn.2d 802, 813-14, 792 P.2d 506 (1990).

Allegations unsupported by citation to authority, facts, or persuasive reasoning cannot sustain this burden of proof. *Id.* A petitioner must present evidence that is more than speculation, conjecture, or inadmissible hearsay. *In re Gronquist*, 138 Wn.2d 388, 396, 978 P.2d 1083 (1999).

IV. ISSUES PRESENTED

Is the Department properly running Brown's community custody terms consecutively since his Snohomish County cause was ordered to run consecutively to his King County cause?

V. ARGUMENT

The Department Properly Runs Brown's Community Custody Terms Consecutively

Brown appears to be arguing that the Department improperly extended his community custody supervision beyond what the courts imposed. Petition, at 3, 5, and 8. He fails to explain, however, why he thinks that the Department is extending the community custody beyond what the courts imposed on him.

Brown's claim fails. Records, *above*, show that in 1997, Snohomish County Superior Court ordered his cause to run consecutively to the King County cause. Since the causes were ordered to run consecutively, the community custody supervision on the Snohomish cause is to run consecutively to the King County one. The Department complies with the 1997 superior court's order by running Brown's community custody term on his 1996 Snohomish County cause consecutively to the 1995 King County cause. It is not extending Brown's community custody beyond what the courts imposed on him.

VI. CONCLUSION

For the reasons, *above*, this Court should deny relief on Brown's claim and dismiss his petition with prejudice.

REGISTRATION REQUIREMENTS

The defendant having been convicted of a sex offense ((a) Violation of Chapter 9A.44 RCW or RCW 9A.64.020 or RCW 9.68A.090 or that is, under Chapter 9A.28 RCW, a criminal attempt, criminal solicitation, or criminal conspiracy to commit such crimes or (b) a felony with a finding of sexual motivation under RCW 9.94A.127, the defendant is hereby notified of sex offender registration requirements of RCW 9A.44.130-.140 and is ordered to register with the county sheriff in accordance with the following registration requirements.

REGISTRATION REQUIREMENTS

- 1. The defendant must register with the Sheriff of the county in Washington state where he resides. When registering, the defendant shall provide the county sheriff with the following: (a) name; (b) address; (c) date and place of birth; (d) place of employment; (e) crime for which convicted; (f) date and place of conviction; (g) aliases used; (h) social security number; (i) photograph; and (j) fingerprints. The defendant must register immediately upon completion of being sentenced if not sentenced to begin serving a term of confinement immediately upon completion of being sentenced. Otherwise, he must register within 24 hours of the time of his release if sentenced to the custody of the Department of Corrections, Department of Social and Health Services, a local division of youth services, a local jail, or a juvenile detention facility.
2. If defendant does not now reside in Washington, but subsequently moves to this state, he must register within 24 hours of the time he begins to reside in this state, if at the time of the move he is under the jurisdiction of the Department of Corrections, the Indeterminate Sentence Review Board, or the Department of Social and Health Services. If at the time of defendant's move to this state he is not under the jurisdiction of one of those agencies, then he must register within 30 days of the time defendant begins to reside in this state.
3. If defendant subsequently changes residences within a county in this state, he must notify the county sheriff of that change of residence in writing within 10 days of the change of residence. If defendant subsequently moves to a new county within this state, he must register all over again with the sheriff of the new county and must notify the former county sheriff (i.e. the county sheriff of his former residence) of that change of residence in writing, and defendant must complete both acts within 10 days of the change of residence.
4. It is a crime to knowingly fail to register in accordance with the above registration requirements.
