ML 97 Merit System Increments

The Supreme Court requests funding to continue providing merit increases for eligible employees. (General Fund-State)

PL SA Create Supreme Court Administrator

The Supreme Court requests \$611,600 in ongoing funding to establish a new position of Supreme Court Administrator. There are a number of areas of court administration that do not fall within scope of responsibility of the Court's Chief Justice, Justices of the Court, any Court departments (Clerk's Office, Commissioner's Office, Reporter of Decision's Office, or the State Law Librar or even the Administrative Office of the Courts (AOC). As a result, these areas have been neglected over the years, resulting in significant deficiencies in the Supreme Court's facilities, information technology management, personnel programs, and overall administrative support.

Like other courts in the State, the Supreme Court receives certain types of administrative support from the AOC in areas such as IT support, basic HR functions, staffing for certain Supreme Court committees and accounting. But the Supreme Court has many specific administrative needs that fall outside the scope of the support AOC can provide. Notably, the Supreme Court is the only court in the State at any level that does not have a court administrator, and so key administrative responsibilities have fallen, often by default, on the shoulders of the Chief Justice's Office, individual justices, or the Clerk of Court. PL SC Merge Law Library into Sup Court

The Washington State Law Library (Library) and Washington State Supreme Court (Court) jointly request that the merger of the Library into the Court begun in 1959, be finally completed by transferring the remaining expenditure authority on an ongoing basis from the Library to the Court. When the Library was merged into the Court in 1959, the transfer of finances was deemed to be a one-time event, which doesn't seem to match the intent of the bill. This request completes the merger intended by the 1959 Legislature. (General Fund-State)

PL SB Offer Externship Stipends

The Supreme Court requests \$720,000 to provide stipends to its externs. Externships are mutually beneficial to the extern and employer. Externs at the Supreme Court help to ease the administrative burden of court staff and increase court efficiency. Currently, courts cannot afford to compensate their externs, which severely limits the size, diversity, and quality of their applican pool. Both the executive and legislative branches have funding to compensate their externs, leaving the judicial branch as the only outlier. (General Fund-State)
