# Washington State Judicial Branch 2025 Supplemental Budget WaTech Funding Reversion

**Agency:** Office of Public Defense

**Decision Package Code/Title:** S3 – WaTech Funding Reversion

## **Agency Recommendation Summary Text:**

The Office of Public Defense (OPD) is reverting back to the state funding that was previously appropriated for OPD participation in WaTech's Small Agency IT Support program. Prior to spending the 2023-2025 appropriation, OPD, in consultation with WaTech, determined that this particular WaTech program is not a good fit for OPD's business needs.

Fiscal Summary: OPD requests the WaTech Small Agency IT Support funding be reverted back to the General Fund.

### **Package Description:**

OPD received funding in the 2023-2025 biennium to participate in the WaTech Small Agency IT Support program. After receiving the funding, OPD determined that WaTech's small agency program is not be able to satisfy OPD's evolving IT business needs. Among OPD's concerns is that WaTech promotes its small agency program for organizations with fewer FTEs than OPD currently employs. This decision package reduces the OPD budget by the amount appropriated because OPD will not be using WaTech's Small Agency IT Support program. OPD will pursue separate funding to engage with other WaTech services that are better aligned with OPD's needs, for example the enterprise shared tenant platform.

Following meetings in spring 2024, OPD and WaTech agreed that the Small Agency IT Support program is not the right fit for OPD. The agencies memorialized the following in a March 20, 2024 email:

- WaTech Will not spend funding on investment to onboard OPD to the Small Agency IT Support program and will not bill OPD for the Small Agency IT Support allocation in Fiscal Year 2025.
- OPD Will not spend this funding elsewhere and will submit a 2025 supplemental budget decision package to be removed from the Small Agency IT Support allocation.

#### Fully describe and quantify expected impacts on state residents.

This decision package reflects fiscally responsive decision making by taxpayer-funded state agencies.

### Explain what alternatives were explored by the agency and why this was the best option chosen.

OPD met with WaTech to discuss how best to meet OPD's IT business needs. The two agencies agreed that OPD will revert the Small Agency IT Support funding back to the state. OPD will pursue separate funding to engage with other WaTech services that are better aligned with OPD's needs, for example the enterprise shared tenant platform.

No consequences. This decision package does not request funding.


