# Washington State Judicial Branch 2025-27 Biennial Budget Fund Software Licensing and Hardware Maintenance Cost Increases

Agency: Administrative Office of the Courts

Decision Package Code/Title: 9Q – Equipment Maintenance and Software

#### **Agency Recommendation Summary Text:**

The Administrative Office of the Courts requests \$615,000 ongoing for the industry-driven transition to subscription fees and increased maintenance and license costs for certain software and hardware products used by the agency. As software licensing models change across the industry from a one-time payment perpetual license to a monthly or yearly subscription-based fee structure, budget adjustments are needed to pay for changes. By industry design, subscription-based fees are more expensive. Additionally, hardware maintenance fees are increasing generally – ranging from a few percentage points to more than twice the previous cost. (General Fund – State)

#### **Package Description:**

Two issues are driving ongoing, current level information technology costs. First, many software licensing models are moving from a perpetual license owned by the purchaser to a subscription-based model. This results in a shift from a one-time purchase to ongoing, annual subscriptions updated for the current user licenses ("trueups"). Just one example is new, subscription-based licenses for VMWare – or software that allows a single computer to be more efficient by running like multiple, virtual machines or "VM" – which will replace our current perpetual licenses. The Administrative Office of the Courts (AOC) will need to change to the subscription service for VMWare before existing, owned licenses are no longer supported by the vendor. Second, many vendors are simply raising prices on software and hardware maintenance. For example, IBM announced prices from single to triple digit percentages on existing products (See Attachment A).

#### Fully describe and quantify expected impacts on state residents.

Without current licenses and maintenance agreements for the Judicial Information System (JIS) infrastructure, systems cannot be managed effectively or sustain system availability for the courts.

#### Explain what alternatives were explored by the agency and why this was the best option chosen.

Delaying purchases would be an option, but not a realistic or practical one. Vendor support is not provided for expired licenses or maintenance agreements. There is no funding in AOC's budget to keep up with this change in the industry. Additional funding is needed to maintain existing services.

#### What are the consequences of not funding this request?

If this request is not funded, AOC will have licenses without vendor support and any outages could not be fixed. A failure due to outdated licenses and unsupported software or hardware could cripple Washington's' JIS.

#### Is this an expansion or alteration of a current program or service?

No, this is not an expansion or alteration of an existing program or service. It would maintain AOC's current software and hardware.

#### Decision Package expenditure, FTE and revenue assumptions:

#### **Goods and Services**

Software and hardware licensing and maintenance fees are experiencing two changes which will result in increased costs.

Maintenance and usage fees. AOC is faced with across-the-board increases to existing maintenance and usage fees. IBM has notified AOC of increases between 6% to more than 100% for maintenance services and a 24% increase for usage. This cost increase is estimated at \$100,000 annually.

Shift from perpetual to subscription licensing. Perpetual licenses are owned outright requiring a maintenance fee for the life of the licenses. Subscription based charges recur monthly or annually and must be paid in perpetuity while the licenses are used. Broadcom recently purchased VMWare and shifted to a subscription model. AOC is expected to incur a 20% increase to shift to annual subscription. Then, AOC is expected to experience a 7% annual increase for that subscription. Replacing the perpetual license is initially estimated at \$200,000, and then will rise each year.
