#### ML 8L Lease Adjustments

The Court of Appeals requests \$142,000 ongoing for increasing lease costs (Divisions I & II) and for building operations and maintenance expenses (Division III). (General Fund – State)

#### ML 97 Merit System Increments

The Court of Appeals requests funding to continue providing merit increases for eligible employees. (General Fund-State)

#### PL 1B Security Funding

The Court of Appeals (COA) requests \$642,000 to provide security services to the three Divisions of the COA. Funding will be used to provide armed security in each courtroom during court hearings and to provide security services as needed to protect judicial officers, staff, and the public. Increased security is critical to securing both the employees of the Court as well as the Judges themselves given the increasing number of threats and the escalating severity of those threats. (General Fund-State)

### PL 1A 2024 Compensation Survey

The Court of Appeals is seeking funding for the implementation of salary increases based upon the 2024 Compensation Survey conducted by the Administrative Office of the Courts. These increases will address pay disparities for targeted below-market positions. The identified positions include administrative assistants, case managers, judicial administrative assistants, and senior case managers. (General Fund – State)
