## Washington State Judicial Branch 2025-2027 Biennial Budget Washington Defender Association Resource Support

#### Decision Package Code/Title: 1R – WA Defender Assoc. Resources

#### **Agency Recommendation Summary Text:**

The Office of Public Defense (OPD) requests \$810,000 to sustain the nonprofit Washington Defender Association's (WDA) resource assistance and case support services to public defense attorneys throughout the state. WDA receives pass-through funding for numerous services that have not received a cost-of-business increase in more than five years. The requested funding includes a new WDA staff position to recruit, train, and provide ongoing technical assistance to investigators for public defense cases.

**Fiscal Summary:** Funding is requested to support statewide public defense resources at the nonprofit Washington Defender Association.

#### **Package Description:**

#### Issues:

For more than 20 years, the Office of Public Defense (OPD) has administered critical pass-through funding to the nonprofit Washington Defender Association (WDA) to implement resource assistance and case support services to public defense attorneys throughout the state.<sup>1</sup> Each year WDA provides thousands of individualized case consultations for criminal public defense attorneys as well as dozens of training programs. However, WDA has not received a cost-of-business increase in more than five years.

During the Covid pandemic, WDA was able to absorb rising business costs with temporary savings from moving all training online. Over the past year, however, WDA has resumed its hallmark in-person CLE seminars as well as onsite visits with public defense providers around the state. Travel and event costs are significantly higher since 2019, including stipends for speakers and to support those with lived experience for their participation. In addition, WDA is in the process of adjusting salaries in order to recruit and retain professional staff in a competitive legal services environment. The nonprofit also faces increased costs for rent, IT, and other basic business operations.

To comply with the Washington State Bar Association's (WSBA) updated Standards for Indigent Defense Services<sup>2</sup>, public defense attorneys likely will need access to more investigator services. The existing pool of experienced defense investigators is extremely limited and defenders already struggle to find competent investigators available to work for them, especially in rural areas and in smaller offices. The current pool includes individuals with various backgrounds and training, and some investigators who may have good forensic skills, such as former law enforcement officers, are not always trained in best defense practices related to client communication. WDA has been able to offer some investigator training, but it is insufficient to train those new to investigation and to provide advanced training.

#### Proposed Solutions:

OPD requests funding to support WDA's ongoing salary, training, and business operations, as well as to add a new investigator resource position at the nonprofit. WDA will hire a full-time staff attorney (or potentially a non-attorney experienced as a defense investigator) to establish a training program that supports current defense investigators and those interested in a career in criminal defense investigation. The WDA staff position will survey the current landscape and coordinate with OPD and local defenders on pathways for recruitment and training to build up defense investigative services consistent with ratios identified in Standard Six of the WSBA Standards for Indigent Defense Services. WDA will provide multi-day in-person investigator training programs as well as stand-alone one-day training and monthly webinar training.

#### Fully describe and quantify expected impacts on state residents.

This decision package ensures that WDA can continue to provide timely response in more than 4,000 case consultation requests and dozens of training sessions each year for public defense attorneys and investigators.

#### Explain what alternatives were explored by the agency and why this was the best option chosen.

OPD inquired about WDA's ability to further raise member dues, use reserve funds, and secure grants. This alternative was rejected because WDA has utilized these alternative fund sources to their maximum capacity.
OPD considered leaving WDA to take their request directly to the Legislature. OPD rejected this alternative because the request is well-aligned with OPD's mission and vision. OPD historically has included WDA requests for pass-through funding in an agency Decision Package.

#### What are the consequences of not funding this request?

Not funding this request will leave WDA with insufficient resources to respond to public defense resource assistance requests during a time of increased need and dwindling numbers of public defense attorneys and investigators.

#### Is this an expansion or alteration of a current program or service?

This decision package funds an investigative resource position at WDA to enhance current training and public defense support services.

The updated Standard is to be implemented by July 2028.
