#### STATEMENT OF RELIEF SOUGHT

# FACTS RELEVANT TO THE MOTION

On December 21, 2018, a mentally incompetent relative, with a criminal record, entered Appellant's home, threatened Appellant, frightened the children, and would not leave. After being physically thrown out, the relative complained to the police. The police arrested the Appellant (home owner) twelve hours later.

#### GROUND FOR RELIEF AND ARGUMENT

The appellant requests that this case be sent to trial, in whole, judged by a twelve member jury for the following reasons:

- 1. The police had no warrant 4<sup>th</sup> Amendment
- 2. The police did not act under color of law RCW 10.31.030

- The arrest was not needed since a notice to appear in court would have been sufficient RCW 7.80.005
- 4. Appellant denied equal protection of the laws 14<sup>th</sup> Amendment

  ARGUMENT

What happened to the term 'peace officers?' It seems the police have too much power and cause more harm than good. Care little for the citizen who pay their salary. A "Shoot first and ask questions later" seems to be the rule of the day. No investigation. No interviewing witnesses. No looking into the record of the person complaining. If a complaint is brought to the police: "someone must be arrested". And that complaint could be unfounded....a way to get back at a relative who disapproves of their life style. Or to hurt someone they don't like. Do you think things should change? Do you think the police have a duty to treat everyone as innocent until proven guilty? Not act as judge and jury before arresting someone on suspicion alone?
