Come now the Appellants, Tamara L. and Jay P. Fleischer by and through their attorney and move this Honorable Court to resinstate the case.

I misunderstood your February 17, 2022, letter. Let me be very clear. As I indicated in the AMENDED SUPPLEMENTAL DESIGNATION OF CLERK'S PAPERS ALREADY PREPARED, FILED, AND PAID FOR, AND THAT DEFENDANTS DID NOT WANT TO BE MADE PART OF THE CLERK'S PAPERS IN THE APPEAL ABOVE, I did not want these clerk papers to be part of this appeal. Since you denied the motion to consolidate this appeal with 835122, these clerk's papers added nothing to the record for the issues in this appeal: whether delivering the summons and complaint to Brittany Fleischer with a 71 IQ and with a "special learning disability" which denied her the ability to read a book, a magazine, or a document was service on a person of adequate discretion; and the extraordinary fraud of

Lisa Carter. In finishing the brief in this appeal, I would not have referenced them. The issues in 835122 are the prospective impact of an increase in the constitutional homestead exemption after the sheriff's sale but which took effect before the court finalized the sale with the order confirming sheriff's sale, and the release of the \$125,000 homestead to the Fleischers so they would not be living in their car when their redemption period expires on April 2, 2022.

Attached are four documents, the one named above, draft and incomplete emergency motion to stay, for release of \$125,000, for reimbursement for payments the Fleischers made on the first mortgage, my draft and incomplete declaration, and Jay Fleischer's Declaration.

Since the trial court in the order appealed in 835122 ruled that it did not have jurisdiction to order the payment of the \$125,000 and you denied the motion to consolidate I am not sure which appeal to file the motion in. So I was intending to file it in both. In drafting the motion, I realized that supplemental clerks papers (CP 929-1013) would be necessary, not for the appeal, but for the emergency motion and, would have filed a supplemental clerk's papers designation.

Please rule promptly. I am going to file the emergency motion and then appeal your decision, if you do not reinstate this appeal,

WHEREFORE the Fleischer pray this Court to reinstate the appeal.

Come now the Appellants, Tamara L. and Jay P. Fleischer by and through their attorney and file this Supplement to Motion to Reinstate Case:

According to RAP 9.6 only a party can designate clerk's papers. Clerks of a superior court cannot; a commissioners of court of appeals cannot; the judges of court of appeals cannot. This Court with its February 17, 2022 letter usurped the prerogative RAP 9.6 vests solely in the Fleischers to designate their clerk's papers. Its designating the clerk's papers exceeded its power as a court. If it believed that CP 929 – CP1013 were improperly before the court, it should have stricken them, as not being designated.

As indicated in the Motion to Reinstate, CP 929-1013 added nothing to the record for the instant appeal, except for the motion to release the \$125,000, which has yet to be filed. It never occurred to this

Respondent Margaret Curtis has filed a motion to enforce the Commissioner's December 15, 2021 warning of a possible dismissal of this appeal and a motion to modify the Commissioner's December 30, 2021 ruling granting an extension of time.
