A. INTRODUCTION

Jerome Ta'afulisia seeks review of, inter alia, the decision by the Court of Appeals in this case holding that statements by his brothers made in a surveillance video were not testimonial under the Confrontation Clause of the federal constitution. State v. Ta'afulisia, No. 81723-0-I, slip op. (Ct. of App. Div. I, filed 5/9/22). This issue does not merit review as the Court of Appeals decision is plainly consistent with prior decisions of the Supreme Court and this Court. However, should this Court accept review on any issue, for the reasons set forth below, it should also take review of the adoptive admissions issue. The statements made by Jerome's brothers on the encampment video were adopted by Jerome and, thus, are not subject to the Confrontation Clause.

B. <u>STANDARD FOR ACCEPTANCE OF REVIEW</u>

"A petition for review will be accepted by the Supreme Court only: (1) If the decision of the Court of Appeals is in conflict with a decision of the Supreme Court; or (2) If the decision of the Court of Appeals is in conflict with another decision of the Court of Appeals; or (3) If a significant question of law under the Constitution of the State of Washington or of the United States is involved; or (4) If the petition involves an issue of substantial public interest that should be determined by the Supreme Court." RAP 13.4(b).

C. <u>STATEMENT OF THE CASE</u>¹

James, Jerome, and their younger brother, J.K.T. (who was prosecuted in juvenile court) all participated in a robbery and shooting in a homeless encampment in Seattle where a man and a woman were killed and three other people were seriously wounded. A key piece of evidence against the brothers was a video and audio taped recording of the brothers discussing the shootings amongst themselves and with their uncle, "Lucky"

and a relative, "Reno." Lucky and Reno were cooperating with police after learning that another relative, "Juice" might be falsely implicated in the crimes.

Jerome and James argued on appeal that the recordings were improper under Washington's Privacy Act and because the recorded statements were testimonial evidence inadmissible under the Confrontation Clause absent an opportunity to cross-examine the declarants because the statements of James and J.K.T. were testimonial. The State responded to the Confrontation Clause arguments with two counter-arguments:

1) the statements were not testimonial because they were adoptive admissions and adoptive admissions are not barred by the Confrontation Clause, and 2) the recording was not testimonial because the primary purpose of the statements was not to create testimony. Br. of Respondent at 38-40 and 41-50.²

² The appeals by Jerome and James were linked but not consolidated in the Court of Appeals. James made a motion to incorporate Jerome's arguments into his appeal, and that motion was granted.

As to the first argument, the State noted that Jerome did not have a right under the Confrontation Clause to confront his brothers because their joint re-telling of the robbery and shooting story meant that Jerome was adopting the admissions of his brothers as to how the events unfolded.

The statements on the encampment recording plainly meet the test for adoptive admissions under ER 801(d)(2)(ii). Jerome did not merely sit mute as his brothers talked about his crime. He listened attentively and interjected comments throughout. His comments augmented the story and highlighted his own participation. He quite plainly adopted his brothers' statements concerning this event. The trial court ruled that the statements were adoptive admissions, 1RP (5/30/17) 840, and Jerome has not assigned error to that ruling.

Br. of Resp. at 39-40. A defendant does not have a right to "confront" statements that he adopted as his own. Br. of Resp. at 40.

The Court of Appeals recognized that an adoptive admission is not hearsay and, thus, might not be subject to the Confrontation Clause, but it then rejected the argument on the

flawed premise that Jerome was silent in the encampment video conversation.

Only the combination of the utterances and Jerome's silence in the face of them tended to prove a fact in issue in the case against Jerome.

Had Jerome adopted his brothers' admissions in a manner other than by silence, the confrontation clause calculus might be different. But here, when it was his silence that was admitted to incriminate him, the speakers who gave meaning to his silence – James and J.K.T – were witnesses against him who were never subject to cross-examination. To determine whether the brothers' utterances fell within the ambit of the right to confrontation, accordingly, it remains necessary to determine whether the utterances were testimonial. The adoptive admission ruling, relying as it does on the evidentiary hearsay rules, does not provide the answer.

Ta'afulisia, slip op. at 7-8.

The court's first factual premise is plainly incorrect.

Jerome made multiple incriminating statements on the recording. This fact is evident from the trial court's pretrial rulings, which properly recognized that all the brothers engaged in the conversation with Lucky and Reno. In fact, counsel is unaware of a single place in the record where the trial court or

the defendant's trial lawyers asserted, much less established, that Jerome was silent during this recorded conversation.

Jerome's active participation in the conversation is evident from the transcript of the videotape and the transcript of the trial, in which Lucky testified at length on an almost lineby-line basis about the video and who was speaking at a given time. The record shows that Jerome made at least the following statements in the recorded conversation:

James: That's what Phat was saying. He was saying that to – to these guys. "Come the – come the fuck around here." (14)

Jerome: Like, telling me like I'm a little kid. (15)

J.K.T: And then some bitches came out, and (inaudible). (20)

James: The girl came out with a fucking, I think it was a shot -- (20)

Lucky: Shotty? (20)

Jerome: She went like this to James (inaudible). (20)

James: (inaudible) fuckin' smoked. (20)

Jerome: she could have shot me (inaudible) I couldn't see.

James: She said, "what the fuck is going on?" Before she even pulled it out. (20)

Reno: You had the .45? (20)

James: Jerome popped (inaudible). And I had -- (20)

Reno: oh, you had the deuce (inaudible)? (21)

Jerome: I fired the .45...cause it was too loud, so he (inaudible). (21)

James: I know, I couldn't, I couldn't keep doing it. (21)

...

Jerome: You don't even know how many people was in there. (51)

Jerome: All I know was I had a full clip. (51)

Jerome: And we didn't go up and 'baadaadaadaa.' (52)

Jerome: We was standing there. We looked around, (inaudible) talking to us, like -- I was like (inaudible) talking to us, like -- I was like (inaudible) bitches. He was like, "Oh, no, y'all n****** don't walk this way." Cause like I'm like, "What? It's the walkway, n*****, what you mean?" (Inaudible). (52)

³ Racial slurs have been redacted from this pleading.

Jerome: transactions and shit. He was just standin' there lookin' at everybody (inaudible). We knew someone was in the tent -- (52)

Jerome: but they didn't - they didn't hear us come up there. The generator's on. (52)

<u>See</u> Appendix A (Table of Record References) and Appendix B (Transcript of Encampment Video).⁴

Even Jerome's opening brief acknowledges that testimony in the record shows that Jerome was not silent. Br. of App. at 13 ("According to Lucky, Jerome mentioned a lady screaming. 2RP 1627. Lucky claimed it was Jerome who said, "all I know is I had a full clip" and admitted to having the .22. 2RP 1649, 1881-82; Exs. 203, 204. Jerome also mentioned that it was loud because of the generator. 2RP 1650; Exs. 203, 204."). This list of Jerome's statements is incomplete as

⁴ Declarants were never identified on the actual transcript because defense counsel persuaded the court that identifying the speakers would interfere with jurors' independent assessment of who was talking. <u>See e.g.</u> CP 77-79. Speakers on the recording were identified by Lucky in his testimony.

⁵ Jerome asserted in his opening brief that "Jerome is not seen on camera saying anything of note." Br. of App. at 12. This

compared to the admissions listed above, but even these acknowledged admissions are significant, because admitting to presence at the robbery and murder scene – as the robbery unfolded – and admissions to carrying a gun and a "full clip" are certainly "of note," for purposes of the adoptive admissions analysis. At a minimum, these assertions prove that Jerome was not "silent" as the Court of Appeals erroneously said.

After rejecting the adoptive admissions argument, the court then considered whether the statements were testimonial under the "primary purpose" test. The court held that the statements of James and his younger brother were not testimonial because the primary purpose test focuses on the declarants' purpose in making the statements. Plainly, the brothers did not talk about the murders and shooting in order to create evidence against themselves. Although the informants

statement in the brief artfully sidesteps Jerome's admissions off-screen, in other words, statements that can be *heard* on the audio portion of the recording, even if Jerome is not shown on the limited camera view at that precise moment.

intended to create evidence against the brothers, their purpose did not control the analysis. Slip op. at 8-24.

D. THIS COURT SHOULD DENY THE PETITION FOR REVIEW BUT, IF REVIEW IS GRANTED, IT SHOULD INCLUDE THE ISSUE WHETHER THE VIDEO WAS ADMISSIBLE BECAUSE STATEMENTS OF JEROME'S BROTHERS WERE ADOPTIVE ADMISSIONS AND, THUS, NOT HEARSAY AT ALL

The issues raised by Jerome in his petition do not meet the criteria for review. The court resolved the Privacy Act arguments under well-established decisions interpreting the statutory requirements of the Act. Its decision does not conflict with those precedents or violate the statute. Thus, those aspects of the court's decision do not meet the criteria of RAP 13.4(b).

The court's decision that statements on the recording are non-testimonial is a constitutional question but, in light of the Court of Appeals' carefully reasoned opinion, it is not a decision which requires review by this Court. Supreme Court precedent plainly supports the conclusion that whether a

statement is testimonial depends on whether the primary purpose of the declarant was to submit evidence against the accused.

Should this Court decide, however, to grant review on the "primary purpose" issue, or any other issue, it should also grant review on the "adoptive admissions" issue. The adoptive admissions argument is an independent basis for affirmance of these murder and attempted murder convictions. The Court of Appeals decision below truncated that analysis on the plainly incorrect factual premise that Jerome was silent during the encampment recording. He was not. Jerome said multiple incriminating things on the recording and, as the unchallenged findings of the trial court establish, his participation makes clear that he was fully adopting the statements of his brothers as they retold their story to Lucky and Reno.

The Court of Appeals decision did not offer any citations to the record or otherwise explain why it was rejecting those findings and the plain evidence in the record and deciding,

instead, that Jerome had been silent. Once this erroneous factual predicate is corrected, it becomes clear that Jerome's Confrontation Clause challenge should be rejected because the Clause does not guarantee a right to cross-examine regarding statements one has adopted, because those statements are not hearsay at all.

There is currently no decision from a Washington appellate court directly holding that an adoptive admission falls outside the Confrontation Clause analysis. This is "a significant question of law under the Constitution ... of the United States." RAP 13.4(b)(3). Review is warranted on this issue if this Court accepts review of any other issue in this case.

E. <u>CONCLUSION</u>

For the foregoing reasons, review should be denied but, if review is granted, it should be granted on the adoptive admissions argument, too.
