#### 1. IDENTITY OF PARTY

Allied Residential-Carriage House ("Respondent") is the Respondent to this Petition for Oral Argument filed by Olasebikan Akinmulero ("Petitioner").

### 2. STATEMENT OF RELIEF SOUGHT

Deny Petitioner's Petition for Oral Argument.

#### 3. FACTS

- 3.1. Petitioner has filed instant Petition for Oral Argument, regarding his Petition for Review to the Supreme Court, citing RAP 17.5(a). He argues that "The Clerk has the authority and discretionary authority to allow Oral Argument on this matter."
- 3.2. Petitioner claims oral argument is justified because Division One's decision "infringe[d] on [his] Human and due process rights. . . ." He also stated that "more importantly" Division One's decision was a "constitutional violation of civil rights Act of 1964. . . ."

#### 4. GROUNDS JUSTIFYING RELIEF AND ARGUMENT

# 4.1. <u>Petitions for Review are Decided Without Oral Argument.</u>

Pursuant to RAP 13.4(i), "The Supreme Court will decide ... petition[s for review] without oral argument." Under RAP 17.5(a), if a General Order allows oral argument regarding a motion a commissioner or clerk may hear it.

Here, rules on appeal explicitly prohibit oral argument regarding petition for review to the supreme court. RAP 13.4(i); see also RAP 17.5(b). Petitioner's argument that RAP 17.5(a) allows a commissioner to set oral argument regarding a petition for review has not merit and is frivolous; petitions for review are not "decided by a commissioner or the clerk" and not general orders allow oral argument for petitions for review. Moreover, the reasons he sets forth for argument are utterly unrelated to RAP 13.4(b) governing reasons to grant petitions for review even some authority allowed the relief he seeks.

# 4.2. <u>Petitioner's Motion is Frivolous, an Explicit Failure to Comply with RAP 13.4(i), and Sanctionable.</u>

"The appellate court . . . may order a party . . . who . . . fails to comply with these rules to pay terms or compensatory damages to any other party who has been harmed by . . . the failure to comply. . . . "RAP 18.9(a). "[P]ro se litigants are bound by the same rules of procedure and substantive law as attorneys." Westberg v. All—Purpose Structures, 86 Wash.App. 405, 411, 936 P.2d 1175 (1997) (citing Patterson v. Superintendent of Public Instruction, 76 Wash.App. 666, 671, 887 P.2d 411 (1994), review denied, 126 Wash.2d 1018, 894 P.2d 564 (1995)).

Here, there is no basis whatsoever to grant Petitioner's motion. Worse, rules of appeal are explicitly contrary to the relief requested. RAP 13.4(i); *see also* RAP 17.5(b). An attorney filing such a frivolous petition blatantly contrary to rules on appeal would surely be sanctioned and so should Petitioner. *See Westberg*, 86 Wash.App. at 411. Respondent respectfully requests one hour and a half of time at \$300.00 per hour, \$450.00,

for having to respond to this Petition.

#### 5. CONCLUSION

Respondent respectfully requests this Petition be denied and that Petitioner be sanctioned as argued above.
