Pursuant to RAP 10.8, Mr. Rowley respectfully cites the following as additional authority in support of his petition for review:

State v. Rivera, No. 38654-6-III (unpublished, filed 3/16/23). In Rivera, the court rejected an argument that the imposition of the Victim Penalty Assessment violated the Excessive Fines Clause, and the majority cited the court's opinion in Mr. Rowley's case among other opinions. Judge Fearing dissented, stating, "I would declare the penalty assessment unconstitutional as applied to Rivera as

explained in my dissenting opinion in *State v. Rowley*, 38281-8-III."

Because the Court of Appeals is now relying on the *Rowley* opinion to support both majority and dissenting opinions, this Court should grant review in *Rowley* to resolve the issue.
