State*, 192 Wn.2d 154, 429 P.3d 484 (2018) for the view that appellate courts should not take cases from the jury. Similarly, in *Cox v. State of Wash.*, *Dep't of Soc.* & *Health Servs.*, ___ Wn. App. 2d ____, 2023 WL 2983116 (2023) Division II upheld a trial court's denial of a CR 50 motion, noting that courts should be appropriately hesitant to take cases away from juries, citing *H.B.H.* Division II also rejected a superseding cause argument.
