Dear Clerk of the Court:

Please include the following additional Authorities as they apply to the many violations made against us as outlined in our Brief and Petition for Discretionary Review:

1. WAC 314-55-410 – Violation of Procedures Act for Marijuana Cooperatives.
2. RCW 34.05.020(g) Inspections and Plant Counts which are designated by individual licenses and Recognition Cards; Time frames for inspections by LCB;
3. RCW 70.124.070 and RCW 70.124.040 concerning LE and Prosecutions failure to report crimes against us, specific to Tobin Meyer and the Office of Skagit County Sheriff's Office, and the Anacortes Mayor's Office, all of whom unlawfully and willingly ignored our attempts to file complaints, and the failure to include the assault on Michael Schermerhorn resulting in heart stoppage on September 5, 2019 and the assault of August 20, 2019 resulting in surgeries because they did not want to accept our multiple complaints concerning 5 burglaries in 2019.
4. Withholding Evidence – RCW 33.36.060, RCW 72.150 - Concealing of surveillance tape showing Tammer O'Conner and associates driving away with our property, and was included in Det. Mike Hansen's report. The tape was never shared with the Courts nor in the Application for a Search Warrant, nor was it ever returned to us.
5. RCW 42.56 Public Records Act – LE and Prosecutions not using the 2019 WSLCB Administrative Records

6. Violations to State, Federal, ADA, WSHRC, and UN Commission Human Rights and Disabilities Laws (Articles 1, 4, 9, 10, 11, 14, 16, 17) by Judge Thomas Verge, Judge Laura Riquelme Elizabeth Yost Neidzowski, and Judge Hayden, all of whom did not consider our health nor our civil rights concerning our disabilities.
