ADDENDUM: REQUEST FOR DIRECTIVE TO KING COUNTY

Request for Immediate Pension Payment and Direct Deposit Authorization

To the Honorable Justices:

Petitioner Aedin Quinn respectfully submits this supplemental addendum in support of his prior Disability Demand and 5th through 9th Motions to Leave to Supplement the Petition for Review. Petitioner now requests the Court issue a directive to King County to initiate immediate payment of pension entitlements and email direct deposit authorization to the address below.

Legal and Evidentiary Basis for Relief:

1. **Dispositive Trauma Evidence (1/7/2018 MRI):** The Virginia Mason spine MRI confirms structural trauma—sufficient to trigger pension entitlement—was present at the time disability was first claimed.
2. **Record Was Incomplete During Denial:** The July 7, 2023 disability denial was issued before this MRI was submitted, rendering the process structurally void under due process doctrine.
3. **Record Correction by Appellant:** The burden of production was impermissibly shifted to Appellant, who successfully located and timestamped the record post-denial, proving eligibility.
4. **Statutory Entitlement Confirmed by Age and Evidence:** Appellant has reached age 62 and is entitled under **RCW 41.40.650 (Pension)** and **RCW 51.32.080 (PPD)** to receive both monthly and lump sum benefits.
5. **Due Process and Judicial Efficiency:** Further litigation is unnecessary. Appellant has proven both entitlement and statutory age. The Court should enforce judgment based on corrected record.

Requested Relief:

Petitioner respectfully requests that this Court:

- **Direct King County to email direct deposit authorization to:** aedinquinn@gmail.com
- **Order retroactive pension to be paid** from July 27, 2017 through present, based on final earnings of **\$163,984** (see attached 2016 W-2)
- **Acknowledge corrected record as dispositive**, fulfilling the legal and constitutional threshold for relief

This directive would avoid continued litigation and align with principles of equity, due process, and lawful finality. Appellant seeks only what the law and corrected record now clearly support.
