Ronald Buzzard Jr., Appellant, herein Pro Se moves this Court to Order the King County Prosecutor to Respond to his Ground that they also failed to respond in the Court of Appeals denying Buzzard any chance at relief, or a fair appeal. Especially since the main reason, or ground for this direct appeal as a matter of right is the fact that the King County Prosecutor illegally, and untimely filed for an FPE- Forensic Psychological Evaluation in violation of RCW 71.09.025(1)(a), and In re Det of Martin, 163 Wn.2d 501, 507, 182 B3d 951 (2008), which the statutes "mandatory language" of the word "shall" required the King County Prosecutor to file the FPE "three months prior" to his release. They filed it 3-1/2 weeks to his release. Buzzard's address was approved, he had hired new employees for his company, he had made arrangements to be picked up. The ISRB suspended

his already approved November 13, 2023 release. The FPE must be reversed, dismissed, removed from all his records, and he be Ordered "Immediately Released" under Martin, and RCW 21.09.025(1)(a)

Thus, since Buzzard's been denied relief, and no reply by the King County Prosecutor, he prays this Court Order them to respond within 20 days, and give him time to reply to their response. Buzzard urges the Prosecutor concede their error and support his petition for "immediate release" under Martin.
