* On 9/28/05 I pulled the YPD records bureau copy of case 93-10596. I read all reports and reviewed the photos from this case. I located some WSP lab reports that indicated the presence of seminal fluid from the vaginal wash and vaginal swabs that were collected at the time of autopsy. The items were tagged I-27596, and I-27597. Both items were submitted to the WSP lab for analysis and then additionally to a private lab in Portland, OR called IMFL. The private lab receipt shows that the items were sent back to YPD in 2000, however the property clerks have not been able to locate such evidence. I inquired to Property Supervisor Julie McGovern about the items of evidence and she had no knowledge of their whereabouts or to who received the items and where they could be stored.

* On 10/4/05 I followed up tracking down the two vital pieces of evidence and called both the WSP crime lab in Spokane, and the private lab in Portland, OR IMFL. I left messages for both agencies with hopes of having a viable source of DNA that could be re-examined further for additional information.

On 10/4/05 Denise Olson from the WSP Crime Lab in Spokane, WA called me to let me know that the sample was analyzed there and that she would have to put in a special request to pull the file out of the archives. She further informed me that this would take two weeks. I thanked her for the information and continued to look.

* On 10/4/05 I contacted IMFL laboratories in Portland, OR about this case. The clerk informed me that if tests were done that the evidence was sent back and that the specific type of test that was done would not be suitable for submission to CODIS. Unless the sample was resubmitted CODIS was not an option at this time.

Once again I pulled all records in this case having to do with the items of evidence in question. I emailed LT. Nolan Wentz as to my findings. He was unaware of my discovery. I had found a report that SGT Bardwell had written on 3/27/00 that he had received a box containing the items of evidence from the private lab IMFL located in Portland, OR. He further placed the items in the refrigerator in the property vault at YPD.

On 10/4/05 I went into the property vault at 1435 and searched all refrigerators in the vault for these items of evidence. I recovered a box in refrigerator #1 that was mislabeled from YPD case numbers and I recognized the IMFL lab number from the side of the box. I opened the box and found the items of evidence that we have been looking for.

I called back WSP Lab and informed them that I would be sending them this package to process for DNA analysis and to further submit the recovered DNA profile into CODIS in hopes of identifying the suspect.

* On 10/4/05 I sealed and packaged three items for submission to the WSP Lab I-27596, I-27597, and I-27601. Please see additional attached reports for more information.

also has contact with several black people near 5th and S. 7th St. and I think it is illicit deal. She contacted them on a vacant lot of 110 S 7th.


