1. Introduction

Petitioner Ames has filed a motion to extend the time to file his response to amici. The motion should be denied, because what his counsel characterizes as mere incompetence is actually an attempt to file an improper reply to Pierce County's answers to the petition for review and to the brief of amici.

2. Relevant Facts

Ames' counsel admits she filed and served on this office her proposed answer many hours after Pierce County's answer to amici was filed, and well after this Court's filing deadline. Pierce County's answer was filed and served by 3:40 p.m. on the due date. Tribe decl. ex. A. Ames' answer was filed and served almost four hours later. Tribe decl. ex. B.

Counsel claims that the late filing was due to her failure to

communicate the deadline to her staff, and her busy schedule. Motion at 2.

She admits that even after she had missed the deadline, she was working on

the brief, although she claims this was only to "finalize" it. Id.

However, the brief Ames seeks to file is really a reply to Pierce

County's response to the petition for review and answer to amici, rather than

merely answering amici's arguments. The brief is laden with references to

Pierce County's "answer" and the arguments the County has made.

Proposed Answer to Amici at 3 n.15, 5, 6 n.24, 7.

Ames does not always specify in his proposed answer whether he is

referring to Pierce County's Answer to the Petition for Review or Answer

to Amici. Compare Proposed Answer to Amici at 24 (citing the County's

Answer to Petition for Review) and 7 (quoting directly from the County's

Answer to Petition for Review and the County's Answer to Amici, but not

supporting the quotation with any citation). However, under RAP 10.3(f)

either would be improper, as they are not "new" matters raised by amici.

The proposed brief reveals that Ames is abusing court rules,

apparently to gain tactical advantage.

3. Argument

The proposed late answer should be rejected for violating two appellate rules. First, briefs must be filed timely on the date fixed by this Court. RAP 10.2(g). They are also to be limited "solely to the new matters raised in the brief of amicus curiae." RAP 10.3(f).

Waiver of the rules is permitted, if it "serves the end of justice." RAP 1.2(c). However, the ends of justice are not threatened by declining to accept a late answer to an amicus brief that is actually an improper reply to a petition for review or response to amici, rather than a true answer to amici.

If this Court allows such rule violations in this case without consequence, it invites further abuses. Pierce County respectfully requests that this Court decline to accept Ames' tardy and improper response to the brief of amici.
