RESPONDENT'S REPLY IN SUPPORT OF MOTION TO STRIKE REPLY TO ANSWER TO PETITION FOR REVIEW

Petitioner Bellevue-Overlake Farm, LLC ("the Sferras") filed an unauthorized reply in support of its petition for review. The Sferras repeatedly concede that the respondent's answer to the Sferras' petition did not seek review of any issue that was not raised in their petition for review. That concession is dispositive because "[a] party may file a reply to an answer *only if* the answering party *seeks review* of issues not raised in the petition for review." RAP 13.4(d) (emphasis added).

The Sferras' reply in support of their petition for review should be stricken. The Sferras accuse respondent Overlake Farms BLK III, LLC ("the Kapelas") in its Answer to the Sferras' petition of "fashion[ing] an alternative basis for affirmance," of asking "that this Court affirm on new and alternative grounds," and attack the "fallacy behind the Kapelas' 'restatement'" of the case in their Answer, all to support the Sferras' argument that their "Reply responds to new issues raised in the Answer." (Opp. 1-2) It is undisputed, however, that the Kapelas asked this Court only to *deny* review of the Court of Appeals decision reversing the trial court's order directing a sale of the parties' cotenancy property.

The Kapelas stand by their Answer, which argues that the Court of Appeals correctly held that the trial court's findings do not support its order directing a Sheriff's sale. Regardless, however, the fact remains that nowhere in their Answer did the Kapelas "seek[] review of issues not raised in the petition for review." RAP 13.4(d). The Court should strike the Sferras' unauthorized Reply in support of their petition for review.
