- I, Mr. Lorenzo Gino Sandoval, declares under Oath and says:
- 1. I am the Petitioner, Plaintiff/Appellant in this matter. I am over the age of 18.
- 2. I am a Citizen Born in the United States of America.
- 3. I am competent to testify.
- 4. I assert the following facts from my own personal knowledge and observations.
- 5. I had a deadline of: November 27th, 2017, to file a PETITION FOR REVIEW, from the entry of the decision of October 24, 2017, from the Washington State Court of Appeals Division II, Case No. 49001-3-II.
- 6. On November 15th, 2017, I mailed Petitioner, Plaintiff/Appellant his NOTICE FOR PETITION FOR REVIEW WITH A POSTAL MONEY ORDER IN THE AMOUNT OF \$200.00 to all parties and Courts in this matter. See: Attached Exhibit-A, (COPY OF POST OFFICE DATED 11/15/17).
- 7. On November 28th, 2017, The Washington State Supreme Court Clerk sent Petitioner a letter explaining that he is late filing his Petition For Review, and that it should have been filed on November 27, 2017. (See: EXHIBIT-B, (Copy of letter from the State Supreme Court Clerk).

- 8. Petitioner should be granted a grace period of the time it took the post office from Kent Washington to Olympia Washington due to Holiday of: Thanksgiving, and it should not have taken 13 days from Kent Washington to Olympia.
- 9. This raises an exception to the Rule due to a holiday with the mailing, and it should not have taken 13 days to be mailed from the Post Office in Kent. See Exhibit-B, (Reciept from Post Office in Kent Washington).

 10. I believe in good faith that I am not late filing my Petition, I Mailed to this Court 13 days early the required documents to go forward with my appeal.

Clerk, Counsel and Mr. Sandoval:

The Petitioner's "PLAINTIFF-APPELLANT'S NOTICE TO THE COURT AND TO DEFENDANT'S COUNSEL, HIS FILING FOR PETITION FOR REVIEW" was received on November 28, 2017, along with a postal money order for \$200 for the filing fee (#24564337143) The matter has been assigned the above referenced Supreme Court cause number.

The notice indicates that the Petitioner intends to file a petition for review. However, any such petition for review would not be timely filed. Pursuant to RAP 13.4(a) the 30-day period in which to file a timely petition for review runs from entry of the decision of October 24, 2017. It is noted that RAP 13.4(a) in pertinent portion provides:

If no motion for reconsideration of all or part of the Court of Appeals decision is made, a petition for review must be filed within 30 days after the decision is filed.

Accordingly, any petition for review should have been filed by November 27, 2017.

The Petitioner may seek an extension of time in which to file the petition for review by filing a motion for extension of time to file a petition for review. Any such motion should be served and filed in this Court by December 27, 2017, and must be accompanied by a proposed petition for review. If both the motion for extension of time and proposed petition for review are not filed by December 27, 2017, this matter will likely be dismissed.

The motion should be supported by an appropriate affidavit establishing good cause for the delay in filing the petition for review; see RAP 18.8 as to extension of time for filings and RAP Title 17 as to the general rules governing motions and the service and filing of the same. A motion for extension of time to file is normally not granted; see RAP 18.8(b).¹

The contents and style of the proposed petition for review should conform to the requirements of RAP 13.4(c), (e) and (f). It is noted that RAP 13.4(f) provides that the petition for review "should not exceed 20 pages double spaced, excluding appendices." I have enclosed for the Petitioner a copy of RAP 13.4 and Forms 9, 5, and 6, and part F of Form 3 from the appendix to the Rules of Appellate Procedure (RAP).

The Court of Appeals Clerk is directed to forward to this Court the entire file in the above-referenced Court of Appeals case.

RAP 18.8(b) states: "The appellate court will only in extraordinary circumstances and to prevent a gross miscarriage of justice extend the time within which a party must file a notice of appeal, a notice for discretionary review, a motion for discretionary review of a decision of the Court of Appeals, a petition for review, or a motion for reconsideration. The appellate court will ordinarily hold that the desirability of finality of decisions outweighs the privilege of a litigant to obtain an extension of time under this section. The motion to extend time is determined by the appellate court to which the untimely notice, motion or petition is directed."
