APPELLANT'S REPLY TO RESPONDENT'S ATTORNEY FEE REQUEST

(Court of Appeals No. 76954-5-I)

(Snohomish County Superior Court No. 12-3-02727-9)

In his Answer to Petitioner's Petition for review, Father interjected a new issue. Namely, he seeks attorney fees for answering Petitioner's petition. This reply is limited to addressing only this new issue.

In his conclusion, Respondent requests attorney fees pursuant to RAP 18.1(j) because he was the "prevailing party." He does so by misrepresenting what RAP 18.1(j) says. Specifically, he left out the prefatory phrase that expressly limits the rule's application to only those parties responding to an unsuccessful petition for review. In its entirety, RAP 18.1(j) states:

If attorney fees and expenses are awarded to the party who prevailed in the Court of Appeals, and if a petition for review to the Supreme Court is subsequently denied, reasonable attorney fees and expenses may be awarded for the prevailing party's preparation and filing of the timely answer to the petition for review.

Respondent, by leaving out this very important prefatory phrase seems to imply that a party responding to a petition for review always receives an attorney fee award. This is incorrect. Only a party who is awarded attorney fees by the Court of Appeals can apply for attorney fees for answering a petition for review. Here, Respondent was not awarded attorney fees by the Court of Appeal. RP 18.1(j) does not apply.

Similarly, Respondent improperly seeks attorney fees from this Court based on Mother's intransigence. Asserting one's legal right to seek review is not intransigence. The Court of Appeals did not find Petitioner intransigent. Respondent has offered no evidence or argument stating how Petitioner may have been intransigence. Without evidence or argument showing the intransigence, Respondent's attorney fee request should be denied.
