I. IDENTITY OF MOVING PARTY

The Department of Labor and Industries, Respondent in this appeal, seeks the relief designated in Part II of this motion.

II. STATEMENT OF RELIEF SOUGHT

The Department requests that this Court strike Masco Corporation's reply, filed in this Court on April 1, 2019.

III. FACTS RELEVANT TO MOTION

On February 22, 2019, Masco Corporation filed a petition review seeking review of Division One's opinion in *Masco Corp. v. Suarez*, ___ Wn. App. __, 433 P.3d 824, 826 (2019). That opinion addressed when the Department of Labor and Industries can issue a penalty to a self-insured employer for unreasonably delaying the payment of wage replacement benefits to an injured worker. The Court of Appeals affirmed the

Department's penalty against Masco for unreasonably delaying the payment of benefits to Alfredo Suarez.

Suarez filed an answer on March 19, 2019. The Department's answer is due April 24, 2019. *See* Clerk's Ruling Granting Extension (March 4, 2019). On April 1, 2019, Masco filed a reply to Suarez's answer.

IV. GROUNDS FOR RELIEF AND ARGUMENT

A party seeks review of a Court of Appeals decision terminating review by filing a petition for review in this Court. RAP 13.4(a). Parties may file answers to the petition. RAP 13.4(d). A party may file a reply to an answer "only if the answering party seeks review of issues not raised in the petition for review." RAP 13.4(d). In such case, the reply "should be limited to addressing only the new issues raised in the answer."

Suarez's answer did not seek review of issues not raised in Masco's petition for review. Masco therefore cannot file a reply. RAP 13.4(d). This Court should strike Masco's reply.

V. CONCLUSION

The respondent Alfredo Suarez did not seek review of new issues in his answer to Masco's petition for review. So Masco cannot file a reply to his answer under RAP 13.4(d). This Court should strike Masco's answer.
