I. IDENTITY OF MOVANT AND RELIEF REQUESTED

The Department of Social and Health Services, through its attorney, Dawn Vidoni, Assistant Attorney General, requests the court for an order granting the Department permission to supplement the record with evidence that Mary Green has passed away. Specifically, the Department asks that the Notice of Death of Incapacited Person, attached as Appendix A to this motion, be added to the appellate record.

Ms. Green passed away in September 2020. Her death occurred after the trial court proceedings in this matter. RAP 9.11 allows for additional evidence on the merits if

(a) additional proof of facts is needed to fairly resolve the issues on review, (2) the additional evidence would probably change the decision being reviewed, (3) it is equitable to excuse a party's failure to present the evidence to the trial court, (4) the remedy available to a party through postjudgment motions in the trial court is inadequate or unnecessarily expensive, (5) the appellate court remedy of granting a new trial is inadequate or unnecessarily expensive, and (6) it would be inequitable to decide the case solely on the evidence already taken in the trial court.

As discussed more fully in the Department's Answer to Petition for Review, Ms. Green's death makes this case moot and it is therefore an important fact that would affect the Court's review of the petition. Moreover, the Department could not have presented this evidence to the trial court. The remaining factors are either met or inapplicable, and the Department respectfully submits that the Court should be made aware of this significant fact.

Accordingly, the Department requests permission to supplement the record with the Notice of Death of Incapacitated Person, attached to this motion as Appendix A.
