Issue #1.

On the methodology of segregating SLAPP attorney fees, the limits of court's discretion, the "Lodestar" method, the nature of the nexus being either temporal triggers or causation or "but for" causation, juxtaposed with this court's having struck .525 from 4.24.510.

Issue #2.

Does RAP 13.4 (b) (3),(4) apply to the following issue:

Assuming viability of a 4.24.510 absolute immunity doctrine for all self-reported child abuse allegations from all minors to otherwise private persons:

Does minority status (per se) put all minors into the class of

persons too young to be "required to call the police" to get .510 absolute immunity, and does the per-se nature of this class of immune persons render as irrelevant the individual capacity of the minor to call (or decline to call) police, the statement's timing, the minor's intent on to whom to complain, as conclusive legal presumptions of fact based on minority status, or can they be relevant disputable factual questions beyond (or within) CR 56 procedures?
