Letter to Supreme Court Re: GR 31.1

Chief Justice Madsen and the Supreme Court asked the Certified Professional Guardian Board to write a letter explaining how its public disclosure provisions compared to the Uniform Disciplinary Act. There has been a great deal of public comment about public disclosure as related to Board records. This matter will be reviewed in more detail at the Long Range Planning Meeting in April.
