1. Meeting Called to Order

Judge Rachelle Anderson called the January 13, 2020 Certified Professional Guardianship Board (Board) meeting to order at 9:04 am.

2. Welcome, Roll Call, Introductions, Announcements and Approval of Minutes

Judge Anderson welcomed all those present. AOC Extern Tamara Maddox was introduced and welcomed to the Board. It was announced staff member Carla Montejo has separated employment with the AOC. Hearing no suggested changes or corrections, a motion was made and seconded to approve the minutes of the November 18, 2019 Board meeting as written. The motion passed.

passed. Judge Lewis abstained.

3. Chair's Report

Judge Anderson reported on proposed trailer legislation that has been introduced to improve the Uniform Guardianship Act, and the next Hearing regarding the UGA is scheduled on January 28, 2020.

4. Public Comment

Certified Professional Guardian Mr. Chris Neil distributed a graphical representation of professional guardians appointed annually in Washington (see attached). Mr. Neil said he believes the data suggests that less restrictive alternatives to guardianship are being used by GALs and the courts.

5. Grievance Update

Staff provided an update on the number of grievances received and closed during November and December, 2019. The Standards of Practice Committee was unable to resolve grievances in November, lacking a quorum of members. Twenty one (21) grievances were resolved in December. Two percent (2%) of all grievances received in 2019 resulted in a reprimand to the CPG. Four percent (4%) resulted in an Advisory Letter Regulation 507.4.

A Board member suggested the Education Committee review the Standards of Practice that are most often cited in grievances and incorporate greater education around those specific areas.

Office of Public Guardianship Coordinator Jennifer Holderman noted her interest in looking at alleged SOP violations, the investigative process and how sanctions are determined, bringing this content more into the light and engaging for CPG education. Ms. Holderman also reported The Guardian Institute has invited participation in their CEU agenda. Judge Anderson extended an invitation for The Guardian Institute to attend regular Board meetings either in person or by telephone.

Dan Smerken shared the feeling among CPGs that the Board needs to see what "a day in the life" is like. CPGs are fearful of the Board and don't see the Board as helpful, but an entity to avoid. Changing that dynamic will be positive. Stacey Johnson felt the continued reduction of open grievances and the elimination of the backlog in 2020 should benefit this relationship.

6. Regulations Committee

The Regulations Committee was thanked for their engagement. Staff reported the committee has reviewed a draft of GR23 for compatibility with the UGA. Changes in CPG qualifications have been discussed. Among those was "crimes of moral turpitude", a term that is falling out of favor. For example, moral character is important for positions of high public trust, but it must be a very individualized consideration. The committee will continue to review and anticipates providing a proposed version of GR23 at the next Board meeting. Once approved by the Board, the updated draft GR23 will be submitted to the Supreme Court. Staff also reported the committee is focusing on the 000 series of the UGA. Regulations are in the works, but GR23 should be completed before moving too far. Commissioner Kiesel commented her goal is to come back to the Board with model rules of professional conduct, including comments that will help guide CPGs.

It was announced Judge Anderson and Stacey Johnson have been invited to present at The Guardian Institute's Annual Fall Conference in Spokane.



Re: Guardian Certification Program

I am writing regarding the future of the Guardian Certification Program. My understanding is that the contract with the University of Washington expires this year. The Guardian Institute had submitted a proposal only to be told that we need to wait for an RFP to be sent out. Time is running short. If the Guardian Board wants a smooth transition, they need to be sending out an RFP very soon. It will take any new contractor, even the UW, some months to get everything set up to start a new program. I am urging the Guardian Board to address this as soon as possible.

Also, I want to address the topic that has been brought up regarding the education requirements for certified professional guardians. Formal education is not a guarantee of a good professional guardian. However, it can be a good way of screening an interested person. I would propose that the Guardian Board entertain an exception for guardian agencies who have long-term employees who wish to become certified as professional guardians. The owner of the agency would have to shoulder the consequences of any problems. I believe that any responsible agency owner would weigh the responsibility carefully before facilitating the cost of getting an employee certified as a professional guardian.
