1. Meeting Called to Order

Judge Rachelle Anderson called the November 18, 2019 Certified Professional Guardianship Board Teleconference to order at 8:00 am.

2. Roll Call, Approval of Minutes

Roll was taken and Judge Anderson welcomed those present telephonically.

Dr. Sanders requested the October 14, 2019 CPG Board meeting minutes be corrected to reflect her presence.

Due to a technical issue, not all Board members were able to review the minutes of the October 14, 2019 meeting. The minutes were subsequently approved, as corrected, via email.

3. Chair's Report

Judge Anderson asked Ms. Johnson to provide an update on the status of the Uniform Guardianship, Conservatorship, and other Protective Arrangements Act (UGA). Ms. Johnson reported working with Judge VanDornick on portions of Article 2 of the UGA, and the SCJA is also working on making changes. A draft version of the proposed trailer bill has been received, and this must be quickly reviewed in preparation for two upcoming legislative meetings. A copy of the trailer document will be forwarded to Judge Anderson and members of the committee.

4. Guardian Grievance Status Update

Ms. Montejo reported there were nine (9) new grievances received and 14 grievances closed during the month of October. Sixty-eight (68) grievances remain open for investigation. Two separate matters are currently in Hearing status and three cases were recently considered by an ad hoc conflicts review committee. Judge Anderson acknowledged the guardian grievance investigators for their work addressing the backlog of open cases.

5. Regulations Committee Update

Ms. King announced the reactivation of the Regulations Committee and described the minimum timeline for regulation adoption in accordance with required Board notice and meeting procedures, as well as complicating factors. The Committee will consider its plan for accomplishing the necessary work due to the UGA's scheduled effective date of January 1, 2021 and priorities at the first meeting of the committee, set for Tuesday, November 26.




