1. Meeting Called to Order

Judge Rachelle Anderson called the June 8, 2020 Certified Professional Guardianship Board Meeting Zoom Video Conference to order at 9:10 a.m.

2. Welcome, Roll Call & Approval of Minutes

Roll was taken of Board members and Staff, and all present were welcomed.

Hearing no suggested additions or corrections, the May 11, 2020 CPG Board meeting minutes were adopted by consensus.

3. Chair's Report

Judge Anderson shared the sad news that Certified Professional Guardian Kristi Kilbourne passed away suddenly. She was well loved in Spokane, was active in the WAPG organization and was an outstanding CPG. Lisa Malpass reported that successor guardians have been found for all but five of Ms. Kilbourne's cases, which are still needed in Stevens and Pend Oreille Counties.

Judge Anderson also remarked on planned stakeholder listening events via Zoom Video Conference, to be held prior to rewriting regulations to conform to the new UGA. Feedback from the listening events will be prepared for Board approval, then will go out for public comments. These listening sessions are intended to make this work a more robust process. The sessions will take place on June 22 at 7:30 am and June 26 at 4:30 pm, facilitated by Judge Anderson and Commissioner Kiesel. Each session will last $1 - 1\frac{1}{2}$ hours. An invitation was sent out to all CPGs.

4. Public Comments

Mr. Tom Coleman presented a mental health report he has written for Adult Protective Services about capacity to consent to sex. While not specifically written for adults in a guardianship, it could be applicable as a tool, and he requests this information be shared by the Board. Ms. Christina Baldwin also spoke as a lay guardian, remarking on Mr. Coleman's materials.

5. Grievance Update

Staff reported seven (7) new grievances received during the month of May, 2020. Six (6) grievances were dismissed for having no actionable conduct and three (3) were dismissed as being outside the jurisdiction of the CPG Board. Forty-two (42) grievances currently remain requiring investigation. Twenty-three (23) of these grievances concern seven (7) Agencies or CPGs with two or more grievances.

6. UW Update

Staff reported that with the passage of the UGA, legislative funding was provided for the redevelopment of the UW certification program. The UW has produced an interactive formal education program, aligning CPGs with other professions, and establishing it as a true profession. This expanded training replaced the previous 2-day training required of CPGs. This is a good opportunity for the Board to participate in providing input on their work as they are revising their program. Rosslyn Bethmann asked if the UW is scheduling an advisory board meeting and staff replied this would typically be scheduled in July, but a date has not yet been established. Judge Anderson thanked the Education Committee for all their hard work on updating the program. Making the program fully virtual will also make it much more accessible state-wide.

Judge Anderson asked about updating the Lay Guardian training, due January 1, 2022, as well as training for Minor Guardianship, due January 1, 2021. These two trainings will be kept separate. Staff has been working on preparing for the new training, including work on pattern forms. Judge Lewis asked if anything has been done to increase non-English speakers' accessibility to the Lay Guardian training. Staff answered this is a known need, but offering the trainings in other languages has not been funded by the legislature.

7. Executive Session (Closed to Public)

8. Reconvene and Vote on Executive Session Discussion (Open to Public)

On behalf of the Applications and Education Committee (Joint Committee), Judge Lewis made a motion to adopt the recommendation of the Joint Committee to allow, for applications submitted through December 31, 2020, for CPG applicants to be certified during the UW hiatus period, subject to completion of the following conditions in lieu of taking the UW certification course:

- Complete a Board CPG application;
- Take and pass the CGC National Certification test and meet all CGC requirements necessary to sit for the test;
- Take and successfully complete a Washington State specific course to be created by AOC staff.

These conditions would need to be completed by June 30, 2021.

The motion was seconded. In favor: Judge Blinn, Amanda Froh, Judge Anderson, Rita Forster. The Applications and Education Committees abstained. The motion passed.

On behalf of the Applications Committee, Judge Lewis presented the following applications for consideration. Members of the Applications Committee abstained.

A motion was made and seconded to conditionally approve Margaret Eckstrom's application for certification upon completion of the UW Certification Program, or the alternate process set out by the Board, with transferrable financial skills. The motion passed.

A motion was made and seconded to conditionally approve Pamela Saari's application for certification upon completion of the UW Certification Program, or the alternate process set out by the Board, with transferrable skills in health care and social services. The motion passed.

9. Wrap Up/Adjourn

Judge Anderson reminded Board members that there is no meeting of the CPG Board in July. The next Certified Professional Guardianship Board meeting will be held on August 10, 2020. With no other business brought up for discussion, the June 8, 2020 CPG Board meeting was adjourned at 11:08 a.m.




