1. Meeting Called to Order

Judge Anderson called the November 9, 2020 Certified Professional Guardianship Board (Board) meeting to order at 8:01 a.m.

2. Welcome, Roll-Call And Approval of Minutes

Roll was taken and members of the Board and the public were welcomed. Judge Anderson reminded members of the public there would be no public comment period today. There will be an opportunity for public comment during the next Board meeting to be held on January 11, 2021.

Motion: A motion was made and seconded to approve the October 12, 2020 meeting

minutes as written. There were none opposed. The motion passed.

3. Chair's Report

Judge Anderson mentioned her participation, and that of Ms. Kay King and Ms. Jennifer Holderman, at the recent Guardian Institute, Spokane 2020, saying the presentations went well. Judge Anderson reported she is preparing for the upcoming Legislative session as a member of the Superior Court Judges Association – Guardianship and Probate Committee, and will focus on things that will affect the CPG Board, for example, vulnerable adult protection orders. Judge Anderson asked Board members to select and appoint a Vice-Chair to the Board, in accordance with Certified Professional Guardianship Board Bylaws, Article V, Section 1.

4. Grievance Status Report for October, 2020

Staff reported there were ten (10) new grievances received and ten (10) grievances resolved in October, 2020. Two (2) grievances were dismissed for No Jurisdiction, six (6) were dismissed for No Actionable Conduct, and two (2) grievances were resolved with an Advisory Letter. A total of sixty nine (69) grievances have been received to date this year, and thirty nine (39) of these have been resolved. Forty-six (46) grievances remain open for investigation. Ms. Bethmann said she appreciated Mr. Fournier noting in his report how grievances have been resolved each month.

Dear Stacey,

Thank you for informing us at UW Continuum College regarding the decision by the CPG Board to continue to certify Guardians during the hiatus and redesign year for our Guardianship Certificate program. We do acknowledge the need for sufficient availability of Professional Guardians during this time, and that certification this year is dependent on fulfilling the following requirements set by the Board; completion of a CPG Board application, meet all Center for Guardianship Certification (CGC) requirements necessary to sit and pass the CGC National Certification test, and complete a two-day training to be provided by the AOC.

We do have concerns about the granting of full certification to students in this interim year and would like to propose that a provisional certification status be granted instead.

Our concerns are as follows:

- The National Certification test and materials do not reflect the comprehensive nature of the UW
 year-long education program, and WA State Guardianship standards of practice and compliance
 requirements are far more advanced (opinion of the WA Association of Professional Guardians,
 WAPG)
- The proposed two-day training by AOC is likely to provide good basic and foundational knowledge in the practice of Guardianship in WA state, but falls short in terms of the essential preparation for good professional practice that the UW program provides
- The time and financial investment for the interim training this year will be a fraction of the cost and effort of taking the UW program, which may be an incentive for people to get certified without sufficient preparation, and could result in grievance issues to follow
- The CPG Board's grievance investigators have been overwhelmed, and there is a backlog of complaints. Insufficient education and training could result in a new wave of grievances
- If many people take the opportunity to become certified during this interim year, with minimal investment required, it could be a disincentive for students to enroll for the Autumn 2021 launch of the new program, which could compromise the financial health of the UW program

UW Continuum College would like to work with the AOC and the CPG Board to ensure the best outcome all around for this hiatus year of our program, and for education and certification of Professional Guardians.

We therefore would like to propose the following:

- Provisional certification be given to students this year based on their meeting the CPG requirements, including interim training, as outlined above
- Presuming that interim training will suffice for the foundational Course 1 of our program, Course
 2 and 3 could be opened for single course enrollment next year so that on successful

- completion, hiatus year students could fully earn our certificate and convert from provisional status to being fully certified by the CPG Board. A waiver for Course 1 of our program could be given under these circumstances
- Going forward, we would also like to offer Course 2 and 3 of the Guardianship program as Single Course Enrollment options (SCE) for certified Guardians who would like to meet further professional education requirements. The updated and revised courses will now be fully online, and may be of interest to this category of students for maintaining certification

I would be very pleased to discuss our concerns and proposals further with you Stacey, and would like to share them with the CPG Board. I would also be happy to take you up on your suggestion of attending the January meeting of the CPG Board to further explore these issues.

Thank you for your work as Chair and to the members of the Certified Professional Guardianship Board for their commitment.

WAPG's members have raised concerns regarding the CPG Board discussing matters in closed-door meetings/sessions that would have been discussed in open meetings/sessions in past years. WAPG disagrees with the CPG Boards current approach and would request the CPG Board reconsider GR 23 proposed revisions be discussed in open meetings/sessions as in years past. This will allow for transparency and participation by the CPG's that the Board regulates. Please find below information that WAPG would request the CPG Board consider regarding this issue.

Contrary to Past Practice: The CPG Board has a history of open meetings/sessions. Attached is a letter from five past Chairs and Vice-Chairs of the Board who agree, closed-door executive-meetings/sessions should not be used for CPG Board discussions regarding anything other what is allowed in GR 23(c)(xii) or CPGB 106.2.1.

Inconsistent with the Board's Rules and Regulations: By rule, CPG Board meetings are "open to the public". GR 23(c)(xii) While some closed-door meetings are required for discipline (and applications CPGB 106.2.1, meetings should otherwise be "open to the public".

Supreme Court Committees: In addition to the CPG Board, the Supreme Court also regulates Interpreters. Like the CPG Board, the Interpreter's Commission (Chaired by Supreme Court Justice González) certifies, tests, and disciplines interpreters. The Interpreter's Commission holds "open meetings" and even publishes detailed minutes of their *sub-committee* meetings. (see: <u>June 5, 2020,110 pages</u>). There is no precedent for Supreme Court regulatory boards and commissions to discuss policy matters in closed meetings/sessions.

The Board is <u>not</u> subject to the Open Public Meetings Act. However, the Board's history and rules follow the spirit of the Act. WAPG believes it is in the best interest of the CPG program to have all policy discussions "open to the public". WAPG is concerned with the Board's assertion that "preliminary discussions" such as GR 23 revisions can only occur in closed door meetings/sessions. There is no support for closed-door meetings/sessions policy discussions in the CPG Board's history, rules, or general trend of organizational transparency.

In this oversight role, the Board conducts affairs as openly as possible pursuant to GR 23 which states "[m]eetings of the Board will be open to the public except for executive session, review panel, or disciplinary meetings prior to filing of a disciplinary complaint." (GR 23 (xii) Meetings)

In our experience, all research, reports, deliberations, discussions and decisions other than for discipline or qualifications for licensure were and should be held in open sessions. Simply put, closed-door Executive Session meetings were not, and should not, be used for discussions of the Board.





RE: Update on the CPG 2021 Washington Supplemental Training (UW Hiatus)

Background:

In the spring of 2020, the University of Washington Continuum College (UWCC) notified the Administrative Office of the Courts Guardianship and Elder Services Office of its intention to put the Guardianship Certificate Program (the Program) on hiatus for the 2020-2021 school year. The UWCC is using the year to redevelop the Program to reflect the Uniform Guardianship, Conservatorship, and Other Protective Arrangements Act (UGA). The UWCC also plans to use the time to move to an exclusively online format to improve accessibility to students across the state. (See May 4, 2020 letter attached hereto.)

The Applications and Education Committees held Joint Committee meetings in May and early June to address concerns related to the absence of the UWCC Program for the 2020-2021 academic year. Significant concerns included: conditionally approved applicants with no training option for an extended period; certification program viability in light of the gap in training availability; and most especially, the continuing needs of vulnerable persons in Washington requiring support from a professional guardian. In light of these considerations, the Joint Committee prepared a recommendation for the Board's June meeting.

At the Board's June 8, 2020 meeting, the Board adopted the Joint Committee proposal for the alternate training requirements for the limited period of the Program's hiatus year. Per the Board action, the alternate training requirements are available only to applicants applying by December 31, 2020, and must be completed by June 30, 2021.

Applicants applying in the designated period may complete the following alternative set of training requirements. (Applicants may also choose to wait and complete the Program when it resumes in the 2021-2022 academic year.) Applicants choosing to become certified pursuant to the alternate training requirements are required to complete the requirements for the Center for Guardian Certification (CGC), and pass the exam administered by the CGC, to become a National Certified Guardian (NCG). Applicants must also complete the Board's application and meet the related requirements of the Board (e.g. background

checks, credit history, education and experience requirements, etc.). The third requirement of the Board's alternate program is that applicants complete a supplemental training to familiarize applicants with Washington specific laws, regulations and practices. Per Joint Application and Education Committee and Board discussion, this course is designed to supplement the training requirements and preparation for the exam required for CGC NCG certification. AOC staff were directed to facilitate the development of a supplemental course of approximately 8-10 hours.

The Board's Education Committee has oversight of the supplemental course structure and content. The Education Committee has had extensive discussion of curriculum priorities given practicalities of the course parameters.

The supplemental course is scheduled to take place entirely remotely (via Zoom) on the following dates:

- Saturday, March 20th, 2021 (8:30 am -4:30 pm)
- Saturday, April 10th, 2021 (8:30 am -4:30 pm)

Each date will consist a total of six (6) hours of course time.

The dates of the course have been shared with applicants and publicized on the guardianship portal website.

Faculty for the supplemental course comprise multiple Certified Professional Guardians, guardianship attorneys, disability rights advocates, judicial officer(s), etc.

Dear Certified Professional Guardianship Board, Certified Professional Guardians, and stakeholders:

The University of Washington Continuum College (UWCC) has advised the Administrative Office of the Courts (AOC) that UWCC must put the Guardianship Certificate Program (the Program) on hiatus for the 2020-2021 school year. The year will be used to redevelop the Program to reflect the newly passed Uniform Guardianship, Conservatorship, and Other Protective Arrangements Act (UGA). The UWCC also plans to use this time to move to an exclusively online format to improve accessibility to students across the state. Providing greater accessibility to potential enrollees from all parts of Washington aligns with demographic trends and the need for entrants to the profession.

The AOC and the UWCC have been in discussions regarding the factors affecting the timeline for the redevelopment of the Guardianship Certificate Program. The UWCC previously planned on putting the program on hiatus for the 2021-2022 academic year. However, recent events and information have brought forth additional impactful considerations.

The effect of the COVID-19 pandemic has left uncertainty in the landscape of the 2020-2021 academic year. The social and economic impacts of the COVID-19 outbreak are unknown but expected to be significant. The potential for lower enrollment in the 2020-2021 academic year is substantial. UWCC informed the AOC that low enrollment would cause the UWCC to place the Program on hold for that particular academic year. While the future remains undefined for all at present, uncertainty is likely to decline over time.

The AOC made a 2020 session legislative request for Program redevelopment funding with input from the UWCC. The Program redevelopment funds request was premised on keeping tuition for the course at the current rate. The Legislature's appropriation for program redevelopment is only available in State fiscal year 2021 (July 1, 2020 to June 30, 2021). Washington State vulnerable adult demographics strongly indicate a continuing need for guardianship services in the state. Maintaining an affordable professional certification course is a critical issue, and ties directly to this appropriation.

The AOC is sharing this information about the 2020-2021 academic year hiatus with all stakeholders as it is understood that this decision impacts all of the guardianship community.
