Dear Judge Lewis:

As I discussed earlier today with Stacey's assistant, Cherie, I am the chair of a subcommittee of the WSBA Committee on Professional Ethics (CPE) that is considering a request for an Advisory Opinion. An inquiry has been made as follows (edited for anonymization purposes):

"May a lawyer who represents a residential care or nursing home facility in seeking a guardianship for a resident, communicate with a proposed CPG during the guardianship proceeding as to the respondent's medical, financial, written and oral statements, and thereafter may the lawyer represent the court-appointed CPG?" It is our understanding that the requestor is concerned with the small number of guardianship lawyers in the county at issue.

Before we begin the drafting process, our subcommittee is interested in the CPG&C Board's input on the potential conflicts of interest. I understand your committee regularly meets on the second Monday of the month, the next meeting being the December meeting. If you could place this item on the CPG&C Board's agenda, and let me know your committee members' initial impressions, we would appreciate that input. If we may have some of your thoughts by the end of November -- so that we would have some comments from stakeholders prior to the next meeting of the CPE on December 8 - that would be very helpful. Once the CPE decides on a direction on how to draft an advisory opinion, and thereafter approve a draft, we would circulate the draft to interested stakeholders for discussion.
