### 1. Meeting Called to Order

Judge Robert Lewis called the April 8, 2024 Certified Professional Guardianship and Conservatorship (CPGC) Board meeting to order at 9:02 a.m.

Deborah Jameson summarized changes to the Uniform Guardianship, Conservatorship and Other Protective Arrangement act that will be effective June 6, 2024.

### 5. Committee Presentations and Overview of Board Authority

As a review and introduction for new members, each of the Board committees presented on their functions. Slides are available on request.

Ms. King presented an overview of the Board's governing authority including Washington State Court Rules General Rule 23 and General Rule 31.1. The presentation also provided an overview of the Board's Bylaws, Regulations, Communication Plan, and Recusal Policy, as well as provisions applicable to the Board of the Uniform Guardianship, Conservatorship and Other Protective Arrangements Act.

Ms. Minogue asked about advisory opinions, which the AAG will follow up with later.

On behalf of the Application Committee, the Chair, Ms. Starrfield presented in regards to the CPGC applications process.

Committee Chair, Ms. Hammond presented on behalf of the Education Committee. In response to a question on who can apply for CEU credit, Ms. Hammond reminded everyone that either the sponsoring program or attendees can request CEU credit for a program.

Committee Chair, Mr. Smerken presented on behalf of the Regulations Committee, describing the Board's regulations adoption process.

Ms. Scott presented on behalf of the Standards of Practice Committee (SOPC) as to the grievance review process.

Ms. Scott presented the Certified Professional Guardianship and Conservatorship Board's Annual Report for 2023, which is available on the website.

Re: Court Orders on Grievances.

Dear CPGC Board:

At the CPGC Board meeting on Monday, April 8, 2024, the Standards of Practice Committee made a presentation on grievances. A question was raised about the Board's review of Superior Court orders that come back on grievances. The discussion seemed to suggest that the CPGC Board might, at times, disagree with the Superior Court's handling of the grievance and that, on occasion, there could be a need to correct an obvious "legal error" made by the court in their order. The Board discussed how this was an area of concern, and that they should look into it.

At that same meeting, you discussed GR 23, which states the CPGC Board (a) is not an appeal mechanism for Superior Court decisions and (b) does not replicate the Superior Court's oversight of the case. Accordingly, there is no opportunity for the CPGC Board to "correct" a court's order on a grievance.

RCW 11.130.670 states: (a) the Board must "accept as facts any finding of fact contained in" a court order and "must act consistently" with those facts<sup>1</sup>; and (b) the court has authority to enforce the Board's standards of practice "to the extent those standards are related to statutory or fiduciary duties of guardians and conservators".<sup>2</sup>
