# 1. Meeting Called to Order

Judge Robert Lewis called the June 10, 2024 Certified Professional Guardianship and Conservatorship (CPGC) Board meeting to order at 9:02 a.m.

# 2. Welcome, Roll Call & Approval of Minutes

Judge Lewis welcomed all present and called for approval of the minutes.

Motion: Ms. Starrfield moved to approve the May 13, 2024 minutes as written. Seconded. The motion passed.

# 3. Chair's Report

Judge Lewis reminded board members to complete the annual Criminal Justice Information Systems (CJIS) training. He also reminded the Board that all members are expected to participate in a minimum of 80% of full Board meetings held during the calendar year.

## 4. Public Comment Period

Board member, Mr. Smerken, remembered long-time CPGC, Kenneth Curry, who passed away recently. Mr. Smerken will forward Mr. Curry's obituary to the Board.

## 5. Education Committee Presentation

Dr. Doyle, Ms. Shirley, and Ms. Frey presented on the University of Washington (UW) Continuum College Guardianship Program. Dr. Doyle announced she will soon be leaving and introduced Meaghan Hurley, who will be taking over her position. The program is divided into three quarters and is fully online. There are thirty-one individuals who will be completing the 2023-2024 program in June. The 2024-2025 Guardianship Certificate course will begin September 25 and run through June 13. The presentation covered application requirements and course content. Ms. Shirley and Ms. Frey gave the overview of course content, detailing case studies and a course focus in cultural humility. Dr. Doyle indicated an increase in graduation and exit survey scores after the UGA revision. Since going fully online, geographic distribution remains consistent, while attendance has increased.

Board members asked questions about writing skills, cultural awareness, reasons students do not complete the course, and surveys/follow-up with course alumni.

## 6. Grievance Report

Ms. Scott presented the May grievance report, which is available in the meeting packet. Last month, the Board received six (6) new grievances. There are a total of twenty-seven (27) unresolved grievances. Currently, there are 249 active CPGCs.

### 7. Overview of Disciplinary Counsel Role

Mr. Manning described the differences between disciplinary counsel and general counsel to the Board. As disciplinary counsel, his duties are to provide advice to the Board regarding disciplinary matters. As general counsel, Ms. Hellwig is assigned to provide the Board general advice not relating to pending disciplinary matter.

Board members asked additional clarifying questions. Mr. Manning works with the SOPC to advise on all actionable avenues. He argues the Board's position as long as there is a legal basis.
