1. Meeting Called to Order

Commissioner Kim called the January 13, 2025 Certified Professional Guardianship and Conservatorship (CPGC) Board meeting to order at 9:00 a.m.

2. Welcome, Roll Call & Approval of Minutes

Commissioner Kim welcomed all present and then called for approval of the minutes.

Motion: Judge Retsinas moved to approve the December 9, 2024 minutes as written. Judge Schmidt seconded. 7in favor. The motion carries.

3. Chair's Report

Commissioner Kim announced that the Board received a letter from Washington Association of Professional Guardians (WAPG) regarding the UW education advisory board and sent it forward to Ms. Meaghan Hurley, the UW Certificate Program representative. He advised that interested parties reach out directly to the UW program.

4. Public Comment Period

Chris Niel spoke as new president of Washington Association of Professional Guardians (WAPG). Mr. Niel stated he appreciates the space for public comment. He expressed interest in having WAPG members on the education advisory board.

Deborah Jameson reminded the board of the importance of reconvening to public meeting at the time communicated, in the spirit of the Open Public Meetings Act. She supports the proposed change to Regulation 205.1, stating that it removes financial barriers to trainings,

increases access to training for remote CPGCs, and lowers administrative cost. She recommends eliminating the CEU application fee.

5. Grievance Report

Ms. Scott presented the December grievance report, which is available in the meeting packet. The board received thirteen (13) new grievances in December. Ten grievances were forwarded to Superior Court. There are a total of forty-one unresolved grievances. Currently, there are two hundred fifty-seven (257) active CPGCs.

6. Regulations Committee

Mr. Smerken announced that two proposed amendments are still in the works. The committee received comments for both pending changes and would like to discuss the public's feedback during the next regular committee meeting before the Board considers adoption.

7. Education Committee

The Education Committee discussed proposed changes to Regulation 205.1. Two comments were received in support of the proposed changes. The Education Committee recommends the Board approve the proposed changes to Regulation 205.1.
