0. Call to Order

As a result of technical difficulties experienced with the toll-free conference call number, Judge Svaren was unable to join the meeting telephonically.

Judge J. Robert Leach called the October 25, 2019, Data Dissemination Committee meeting to order at 9:05 am.

1. October 25, 2019 Meeting Minutes

Hearing no suggested changes or additions by the Committee, the June 28, 2019, Data Dissemination Committee meeting minutes were approved as written.

2. Sealed Cases Not Displayed in Odyssey

Ms. Miner provided an update to the Committee regarding sealed case records that are dropped from screen view in the Odyssey Portal case management system, putting it out of compliance with GR 15 public index rule requirements. With a name and case number, customers can currently look in JIS-Link to see the existence of sealed cases. JIS-Link is a paid system, however, and it is not completely reliable. Mr. Keeling thought that JABS (Judicial Access Browser System) displayed sealed case records correctly, but Ms. Miner pointed out it does not include all cases, like guardianship or civil cases. Mr. Keeling reported that the time required by Tyler Technologies to redesign Odyssey software is estimated to be 2100 hours, at a cost of \$388,000. The courts of limited jurisdiction are currently in talks with Tyler Technologies to develop their new case

management system, so Judge Leach proposed that this work could be included with that project. Mr. Bell has been in discussion with counsel, and will gather more information and report back to the Data Dissemination Committee at its next meeting.

3. Other Business

Judge Leach announced the Commissions, including the Judicial Information System Committee, plan to host a reception for Chief Justice Mary Fairhurst at the Temple of Justice from 3:00 pm – 8:00 pm on December 18, 2019. There will be more information shared about this reception at the next meeting.

With no other business to discuss, the October 25, 2019 Data Dissemination Committee Meeting was adjourned at 9:30 am.
