# **Part II: Narrative Explanation**

## II. A - Brief Description Of What The Measure Does That Has Fiscal Impact on the Courts

#### 2SHB 1469:

The second substitute bill clarifies that payment credentials collected on behalf of state agencies must be accepted and stored by a third-party

institution that is fully compliant with industry-leading security standards. The second substitute bill would have no fiscal impact for Administrative Office for the Courts.

#### SHB 1469:

The substitute bill provides a definition for "payment credentials," and replaces all instances of the term "cardholder data" in the original bill with "payment credentials." All references to the "Payment Card Industry Security Standards," a specific set of payment card industry security standards, are removed in the substitute bill; instead, agencies are directed to store data with "third-party institutions" compliant with "industry leading security standards," where applicable.

The third-party institution that Administrative Office for the Courts uses is compliant with industry leading security standards. The substitute bill would have no fiscal impact for Administrative Office for the Courts.

### Original Bill:

The bill prohibits state agencies from holding cardholder data or other payment credentials on state data systems. State agencies that currently hold payment credentials or other sensitive data are required to work with the Office of the Chief Information Officer (OCIO) to eliminate the data from their data systems.

The Administrative Office of the Courts does not currently store cardholder data or payment credentials in our systems. This bill would have no fiscal impact.
