Part II: Narrative Explanation

This bill would create the Safety and Access for Immigrant Victims Act, which would require certifying agencies to make a determination and complete certifications for “U” or “T” nonimmigrant visa requests from immigrant crime victims.

The bill would require the Criminal Justice Training Commission (CJTC) to develop minimum standards for a course of study on “U” and “T” nonimmigrant visas and other legal protections for immigrant survivors of criminal activities.

The bill would establish the Crime Victim Certification Steering Committee to monitor the implementation, development of training, and dissemination of information to the public regarding the Safety and Access for Immigrant Victims Act.

Part II.A – Brief Description of what the Measure does that has fiscal impact on the Courts

This bill would amend RCW 7 (special proceedings and actions) to create the Safety and Access for Immigrant Victims Act. The bill would provide procedures for victims of criminal activity or trafficking to obtain law enforcement certification on U.S. citizenship and immigration services forms.

Judicial education would be required to ensure understanding and compliance with the new proceedings and certifications. This would be managed within existing resources.
