Part II: Narrative Explanation

This bill would modify and expand chapter 77.55 RCW (construction projects in state waters). The bill would provide permit review and approval processes and fees for hydraulic projects. Authorizes the Department of Fish and Wildlife (WDFW) to issue notices to comply, stop work orders, and civil penalties.

Part II.A – Brief Description of what the Measure does that has fiscal impact on the Courts

Section 8 provides that the WDFW may apply for an administrative inspection warrant in either Thurston County or the superior court in the county where the project is located. The court may issue a warrant where there is a need to inspect the project site to ensure compliance with the law or where there is probable cause to believe a violation has occurred.
