#### **Part II: Narrative Explanation**

This bill would prohibit the manufacturing, possession, distribution, import, transfer, selling or offering to sell, or purchasing an assault weapon or large capacity magazine.

# Part II.A – Brief Description of what the Measure does that has fiscal impact on the Courts

Section 1(27), (28), (29), and (30) – RCW 9.41.010 would be amended to define "assault weapon", "detachable magazine". "large capacity magazine", and "secure gun storage".

Section 2(1) – Would provide that no person in this state may manufacture, possess, distribute, import, transfer, sell, offer for sale, purchase, or otherwise transfer any assault weapon or large capacity magazine, except as allowed in Section 2(2), or Section 2(3) properly store or secure the assault weapon or large capacity magazine.

Section 2(2) – Would define special circumstances allowing the possession, manufacturing, offering for sale, sale, import, and purchase of an assault weapon or large capacity magazine.

Section 2(4) – Would create a new class C felony for a person found guilty of violation of the proposed new section of RCW 9.41.

This bill could result in more criminal cases filed in district courts (for arraignments) and superior courts. No Judicial Information System (JIS) data exists to provide an estimate of how many additional criminal cases would be added, but it is thought to be minimal. The Law Tables would need to be updated. This could be managed within existing resources.
