## Part II: Narrative Explanation

This bill would increase the traffic infraction base penalty for driving continuously in the left lane from $\$ 48$ to $\$ 70$.

## Part II.A - Brief Description of what the Measure does that has fiscal impact on the Courts

This bill would amend RCW 46.61.100 to increase the base penalty amount for continuously driving in the left lane from $\$ 48$ to $\$ 70$.

## II.B - Cash Receipt Impact

The Administrative Office of the Courts (AOC) reviewed Judicial Information System (JIS) data to provide an estimate for the potential revenue increase proposed by this bill. Table I, below displays data from 2012 through 2016 for the number of RCW 46.61.100 infractions.

Table I - Number of Infractions, RCW 46.61.100 Fail to Drive in Right-Hand Lane

Using 2016 as an example, if the base penalty was paid at $\$ 48$, an increase to $\$ 70$ for the base penalty would result in a $\$ 22$ increase per infraction. Table II, below, displays the effect.

Table II - Estimated Revenue Increase

| 2016 Infractions | Current \$48 Base | Proposed \$70 Base | Potential Increase |
| :---: | :---: | :---: | :---: |
| 1,102 | $\$ 52,896$ | $\$ 77,140$ | $\$ 24,244$ |

Note: The maximum fine is not always ordered, not all fines are collected in full, and fines sometimes take years to collect. Estimated revenue is displayed for information purposes only.

## II.C - Expenditures

Existing AOC resources would be used to make minimal modifications to the JIS to reflect the new penalty amount.
