Part II: Narrative Explanation

This bill would require the Caseload Forecast Council (CFC) to prepare and submit to the Legislature a general disproportionality report. The report would be required to be submitted prior to each legislative session. The report would be required to contain:

- a) A table of percentages based on the total number of adult felony sentences in each crime category, distributed by race and ethnicity;
- b) A table of percentages of Washington's general adult at-risk population between the ages of 18 and 54, distributed by race and ethnicity;
- c) A complete list of felony offenses in each crime forecasting category; and
- d) A discussion of limitations in the data presented in a) and b) above.

The bill would provide that the CFC may request from the Administrative Office of the Courts (AOC), the Department of Corrections, and other agencies, data, information, and data processing assistance as it may need to accomplish its duties, and the agencies would be required to provide the information to the CFC without charge.

The bill would require the Minority and Justice Commission, in consultation with the Sentencing Guidelines Commission, to conduct an evaluation of the implementation of this bill and submit a report to the legislature by January 1, 2021.

Part II.A – Brief Description of what the Measure does that has fiscal impact on the Courts

Section 6 – Subject to funds appropriated for this specific purpose, the bill would require the Minority and Justice Commission, in consultation with the Sentencing Guidelines Commission, to conduct an evaluation of the implementation of this bill and submit a report to the legislature by January 1, 2021. The report would be required to include:

- 1) Whether the information provided in racial and ethnic impact statements was presented in a clear, concise, and understandable form;
- 2) Whether any limitations in transmission of relevant data to the CFC existed in the pilot project;
- 3) The timeliness of the provision of racial and ethnic impact statements;
- 4) Whether the implementation of racial and ethnic impact statements let to more equitable outcomes in the criminal justice system;
- 5) A recommendation as to whether to continue the provision of racial and ethnic impact statements on a permanent basis, including expansion of racial and ethnic impact statements into additional subject matter areas, such as legislative bills and resolutions affecting other parts of the criminal justice system.

The AOC would require a Court Program Analyst (0.25 FTE) to provide the expertise needed to evaluate data, participate in the preparation of reports, and provide recommendations and reports required by Section 6 to the Legislature. The annual cost would be \$24,367.
