## Part II: Narrative Explanation

This bill would enact the Washington State Charter of Personal Data Rights.

This bill would provide individual's rights in regards to personal data that a business collects or processes about that individual, including the categories and specific pieces of personal data the business collects or processes. The bill would provide the rights to access and obtain the individual's personal data collected or processed by a business, the right to opt out or object to the selling or licensing of the individual's personal data to third parties, the right to correct inaccurate personal data, and the right to delete all personal data of the individual collected or processed by a business.

The bill would provide for the responsibilities of businesses in regards to individual's personal data.

The bill would provide that any violation of the Charter would constitute an injury and any individual whose rights had been violated or personal data collected or processed in violation of the Charter may bring a civil action for declaratory relief, injunctive relief, and actual damages.

## Part II.A – Brief Description of what the Measure does that has fiscal impact on the Courts

Section 4(5) – Would provide that a court shall award costs and reasonable attorney's fees to a plaintiff who prevails in an action under this charter.
