Part II: Narrative Explanation

This bill would amend RCW 9.94A.832 to provide for a special allegation in a criminal case regarding a marijuana retail outlet wherein a defendant committed a robbery as a premeditated act in concert with another individual or individuals.

This bill differs from SB 6033:

Would remove the requirement that law enforcement must report robberies of marijuana retail outlets to the Washington State Patrol (WSP), and the WSP's reporting requirements to the Liquor and Cannabis Board (LCB). Each marijuana retail outlet would be required to report any attempt or incident of robbery to the LCB within ten days of the incident. The LCB's chief enforcement officer would be required to consult with the WSP concerning the reported incidents, such as evidence indicating a pattern of, or coordinated effort by, an organized criminal enterprise.

Part II.A – Brief Description of what the Measure does that has fiscal impact on the Courts

Section 2(2) – Would amend RCW 9.94A.832 to provide for a special allegation in a criminal case regarding a marijuana retail outlet wherein a defendant committed a robbery as a premeditated act in concert with another individual or individuals.
