Part II: Narrative Explanation

This bill would require the Department of Corrections DOC in conjunction with the Administrative Office of the Courts to create a sentencing elements worksheet. This bill would also amend RCW 9.94A.585(7) which would allow DOC to file a petition with Court of Appeals for a review of a sentence committing an offender to the custody or jurisdiction of the DOC when there are missing, incomplete, or illegible mandatory sentencing element worksheets.

Part II.A – Brief Description of what the Measure does that has fiscal impact on the Courts

Section 3 – Would require the Department of Corrections in consultation with the Administrative Office of the Courts (AOC), the Superior Court Judges Association, Washington Association of Prosecuting Attorneys, Washington Association of Criminal Defense Lawyers, Washington Public Defender Association, and The Washington Association of County Clerks to develop a mandatory sentencing elements worksheet to be used to identify and record the elements of the court's order that are required by the Department to calculate an offender's confinement term and community custody term. The AOC will need to include the worksheet in with its felony judgement and sentence forms.

Section 6(7) – Would amend this section of RCW 9.94A.585 to include a review by the Court of Appeals when there is a missing, incomplete, or illegible mandatory sentencing elements worksheet required pursuant to RCW 9.94A.480(1)
