Part II: Narrative Explanation

This bill would make various changes to felony sentencing laws.

Part II.A – Brief Description of what the Measure does that has fiscal impact on the Courts

Section 1 – Would amend the definition for pattern of street crime gang activity by removing a felony conviction for offenders eighteen years or older with a special finding involving a juvenile drug offense.

Section 2(3)(e)(i) – Would allow the court to require any person sentenced to multiple firearm enhancements to have these enhancements run consecutively.

Section 2(4)(e)(ii) Would allow the court to require any person sentenced to multiple deadly weapon enhancements to have these enhancements run consecutively.

Section 2(7) – Would require persons found guilty of vehicular homicide where there are three prior offenses as defined in RCW 46.61.5055 that all sentencing enhancements must be served in total confinement.

Section 2(10) – Would remove the standard range multiplier for criminal street gang felony for person over eighteen where they has been found guilty of encouraging a minor to participate in the crime.

Section 5(2) – Would allow for early release / good time for an offender who has been convicted where deadly weapon enhancements under RCW 9.94A.533 apply or when an offender has impaired driving and minor child enhancements as part of their sentence.

Section 8 – Would allow defendant's currently serving enhancement time or prosecutor's to petition the sentencing court for resentencing on the basis that the consecutive sentence no long furthers the interests of justice. The court would have discretion to resentence, but the new sentence cannot be longer. The prosecutor must notify the victims before the resentencing hearing.

Section 9 – Would repeal RCW 9.94A.833 (Special allegation—Involving minor in felony offense—Procedures) and RCW 69.50.435 (Violations committed in or on certain public places.)

Section 10 – Would provide that the changes in this bill are retroactive and the Department of Corrections must recalculate the defendant's sentences that are affected by this bill.
