Part II: Narrative Explanation

This bill would establish an early childhood court program for young children and their families involved or at risk of becoming involved in the child welfare system.

This bill differs from SB 5331:

Would provide that the early childhood court program is limited to children under the age of three, although they may stay in the program if they enter before the age of three. Would provide that the program is limited to dependent children. The bill adds language to the intent section regarding funding for the for the first year and ongoing.

Part II.A – Brief Description of what the Measure does that has fiscal impact on the Courts

Section 2(1) – Would provide that a superior court may establish an early childhood court program.

Section 2(2) – Would provide that if a superior court creates an early childhood court program, the court would be required to incorporate the core components (detailed in Section 2(2)(a) through Section 2(2)(j) into the program.

Section 3 – Would provide that the judges of a superior court judicial district with early childhood court programs shall adopt rules directing the program, including the specifics detailed in Section 3(1)(a) and (b).

Section 3(2) – The Administrative Office of the Courts (AOC) would be required to administer the certification of training requirements.

Section 4(1) – Would provide that the AOC shall perform, or contract for, an evaluation of the early childhood court program to ensure the quality, accountability, and fidelity of the programs' evidence-based treatment. Any evaluation of the early childhood court program shall be posted on the AOC website.

Section 4(2) – Dependent upon funding provided for the purpose, this bill would provide that the AOC may provide, or contract for, training and technical assistance related to program services, consultation, and guidance for difficult cases, and ongoing training for court teams.

The bill has no effective date, so it is assumed the bill would be effective 90 days *sine die*.

II.B - Cash Receipt Impact

II.C – Expenditures

The AOC would be required to administer the oversight and training for the statewide early childhood court program (Section 3(1) and Section 4(2)). This would require 1.0 FTE Program Coordinator. Standard costs for goods and services, training, travel, and equipment are included. This position would be ongoing.

The AOC would be required to provide an evaluation of the statewide early childhood court program and post the results of this evaluation on the AOC website (Section 4(1)). This would

require 0.6 FTE Research Associate and 0.5 Web Integrator. Standard costs for goods and services, training, and equipment are included. These positions would be ongoing.

Section 4(2) of this bill provides that if funding is available, the AOC shall provide training and technical assistance related to program services, consultation, and guidance for difficult cases, and ongoing training for court teams. This cost is estimated at \$25,000 per year.

Estimated Costs – Superior Courts

It is unknown how many superior courts will establish early childhood court programs. For illustrative purposes, the following information is provided:

Pierce County has established an early childhood court program (also known as “Baby Court”). Based on information provided by Pierce County, successful implementation requires a full-time 1.0 FTE coordinator / guardian ad litem, and 0.25 FTE court appointed special advocate (CASA) at an estimated annual cost of \$128,000 per court for both positions. It is estimated that an additional half day per month of court time would be required, resulting in a cost of approximately \$5,000 per year. These costs are based on the Pierce County 2019 caseload of 12 cases.
