## Part II: Narrative Explanation

This bill would:

- Remove sex offender registration requirements for sex offenses committed under 18 years of age; and
- Remove certain sentencing enhancements in adult courts.

# Part II.A – Brief Description of what the Measure does that has fiscal impact on the Courts

This bill would retroactively remove the legal obligation of an offender to register as a sex offender for an offense committed while under the age of 18. The bill would also create various new crimes called "problem of sexual behavior" which would apply to persons under the age of 18. The bill would make changes to the rape of a child (deleting the marriage exception) and other sex offense statutes (creating "as a minor" designation to all sex offenses).
