Part II: Narrative Explanation

II. A - Brief Description Of What The Measure Does That Has Fiscal Impact on the Courts

This bill would amend Chapter 71.09 RCW (Sexually Violent Predators) intending to improve community safety and justice in the civil commitment of sexually violent predators.

Section 2 would further define least restrictive alternative to include placement in a facility owned, operated, or under contract with the Department of Social and Health Services.

Section 3 would require the court to send notice of a placement to the prosecuting agency in the county where the person will be conditionally released. The section also amends the court process to follow when an offender petitions the court for a specific less restrictive alternative.

This bill would have minor impact to the Administrative Office of the Courts by requiring this information to be included in court education.

The total impact to courts is indeterminate, but likely very low. The courts would experience additional fiscal impact because they would be required to send out additional notices to the county prosecutor's office when placement of least restrictive alternative is granted. The estimate per case is an additional 15 minutes for Clerks to provide the notice as long as the court order includes complete contact information for the receiving county prosecutor.

There have only been 68 filings for Petition for Civil Commitment for Sexually Violent Predators over the past five years. We estimate that during that time, only 2 cases would meet the criteria of bill.
