Part II: Narrative Explanation

II. A - Brief Description Of What The Measure Does That Has Fiscal Impact on the Courts

The bill would amend and add a new section Chapter 13.34 RCW, Juvenile Court Act – Dependency and Termination of Parent-Child Relationship addressing the threat of harm to children due to parental use or possession of a high potency synthetic opioid.

Section 2 would modify RCW 13.34.030 to define high potency synthetic opioid as a schedule I or II controlled substance and includes, but is not limited to, fentanyl.

Section 3 would modify RCW 13.34.065 (Shelter Care Hearing) to create a justification for removal of a child to prevent imminent physical harm when a parent's use or possession, or failure to protect a child from another's use or possession of a high potency synthetic opioid.

Section 4 would modify RCW 13.34.130 (Disposition Order) to include a provision for no parent or guardian available to care for a child when a parent has deficiencies that jeopardize the child, including results of substance abuse, or the parent's use or possession, or failure to protect a child from another person's use or possession, of a high potency synthetic opioid.

II. C - Expenditures

Since 2020 courts have experienced decreased dependency case filings for a variety of reasons, including efforts to more robustly serve families in their communities. The assumption is that this bill would reverse that trend, return dependency case filings to the pre-2020 levels, and shift judicial workload back to the pre-2020 levels.

IMPACT ON THE ADMINISTRATIVE OFFICE OF THE COURTS (AOC)

Training

Funds would be required for training judicial officers and court communities across the state about fentanyl, child safety and the new legal requirements (\$50,000).

Court Forms

This bill would require dependency form modifications.

Legal Services Senior Analyst. Beginning July 1, 2024 through June 30, 2025, AOC would require salary, benefits, and associated standard costs for 0.01 FTE to update required court forms.

AOC STAFF IMPACTS INCLUDE STANDARD COSTS

Salary estimates are current biennium actual rates at Step L. Benefits are the agency average of 30.59% of salaries. Goods and Services are the agency average of \$3,600 per direct program FTE. Travel is the agency average of \$2,000 per direct program FTE. Ongoing Equipment is the agency average of \$1,800 per direct program FTE. One-time IT Equipment is \$4,800 for the first fiscal year per direct program FTE. Agency Indirect is calculated at a rate of 25.86% of direct program salaries and benefits.

IMPACT ON COUNTIES (Superior)

For the purposes of this judicial impact note, AOC expects if this legislation passes the trend of decreasing dependency filings would reverse.

The average number of dependency filings in 2018 and 2019 were 4,400. Subtracting the 2022 dependency filings from that number (2,608) would equate to an estimated 1,792 additional cases to be filed beginning in FY 2025.
